

CITY OF TORONTO

BY-LAW 390-2020

To amend City of Toronto Municipal Code Chapter 886, Footpaths, Pedestrian Ways, Bicycle Paths, Bicycle Lanes and Cycle Tracks, respecting Borden Street, Brunswick Avenue, College Street, Ulster Street.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 886, Footpaths, Pedestrian Ways, Bicycle Paths, Bicycle Lanes, and Cycle Tracks, is amended as follows:

- A. By deleting from Schedule D (Designated Lanes for Bicycles) the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Lanes)	(From Column 4 Times or Days)
College Street	Manning Avenue and Spadina Avenue	Eastbound and Westbound lanes adjacent to the curb lane used for parking	Anytime

- B. By inserting in Schedule D (Designated Lanes for Bicycles) the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Lanes)	(In Column 4 Times or Days)
Borden Street	Cyril Lane and Ulster Street	Westerly Southbound	Anytime
Brunswick Avenue	College Street and Ulster Street	Easterly Northbound	Anytime
Brunswick Avenue	Bloor Street West and Lowther Avenue	Easterly Northbound	Anytime
Brunswick Avenue	Harbord Street and Sussex Avenue	Easterly Northbound	Anytime
Brunswick Avenue	Sussex Avenue and Bloor Street West	Westerly Southbound	Anytime

College Street	Manning Avenue and Spadina Avenue	Westbound lane adjacent to the curb lane used for parking	Anytime
Ulster Street	Borden Street and Brunswick Avenue	Northerly westbound lane adjacent to the curb lane used for parking	Anytime

C. By inserting in Schedule E (Cycle Tracks) the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Lanes)	(In Column 4 Times or Days)
College Street	A point 55 metres east of Lippincott Street and Borden Street	Southerly Eastbound	Anytime
College Street	Borden Street and Bellevue Avenue	Southerly Eastbound lane adjacent to the curb	Anytime
College Street	Borden Street and Bellevue Avenue	Southerly westbound lane adjacent to the southerly eastbound cycle track	Anytime
