

## CITY OF TORONTO

### BY-LAW 411-2020

#### To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Bloor Street West, Harbord Street and Shaw Street.

The Council of The City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

| (From Column 1 Highway) | (From Column 2 Side) | (From Column 3 Between)  | (From Column 4 Prohibited Times and/or Days)  |
|-------------------------|----------------------|--|---|
| Shaw Street             | East                 | A point 85 metres north of Harbord Street and a point 123 metres further north | Anytime   |
