## CITY OF TORONTO

## BY-LAW 430-2021

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting prohibited turns on Camden Street at Brant Street.

Whereas Toronto and East York Community Council on July 4, 2018 adopted Item TE34.176, wherein recommendation 15 of the letter (July 3, 2018) from Councillor Joe Cressy recommended prohibiting westbound left turns at all times on Camden Street at Brant Street, bicycles excepted; and

Whereas Toronto and East York Community Council at its meeting of July 4, 2018 enacted By-law 971-2018, being a by-law "To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Brant Street and Camden Street" and inserted in Schedule XXXIII (Prohibited Turns) an entry for Camden and Brant Street, inadvertently leaving out the phrase "bicycles excepted"; and

Whereas pursuant to Section 169-5.2B of City of Toronto Municipal Code Chapter 169, Officials, City, the City Solicitor, in consultation with the City Clerk, may submit bills directly to Council to make technical amendments to the Municipal Code and other by-laws to correct technical errors, to update the by-laws to refer to the current statute, City official title, administrative unit and Municipal Code provision and to repeal by-laws of the former municipalities that have been superseded by provisions in the Municipal Code or as a result of an administrative reorganization;

The Toronto and East York Community Council enacts:
