BY-LAW 483-2021

To amend By-law 322-2020, as amended by By-law 342-2020, By-law 666-2020 (as amended by By-law 912-2020), By-law 845-2020 and By law 58-2021 to retain physical distancing regulations with respect to Parks;

To amend By-law 323-2020, as amended by By-law 342-2020, By-law 666-2020 (as amended by By-law 912-2020), By-law 845-2020 and By law 58-2021 to retain physical distancing regulations with respect to Public Squares;

To amend By-law 541-2020, as amended by By-law 664-2020, By-law 845-2020, By-law 58-2021, By-law 263-2021 and By-law 368-2021; and By-law 664-2020, as amended by By-law 845-2020 and By-law 58-2021, to retain requirements for the wearing of masks or other face coverings;

To amend City of Toronto Municipal Code Chapter 354, Apartment Buildings, Section 354-3.11.A, to retain requirements reducing the risk from COVID-19; and

To amend City of Toronto Municipal Code Chapter 545, Licensing, Section 545-8.4.1.C.(3), to retain requirements reducing the risk from COVID-19 at establishments serving food and drink.

The Council of the City of Toronto enacts:

1. City of Toronto By-law 322-2020, as amended by City of Toronto By-law 342-2020, City of Toronto By-law 666-2020 (as amended by City of Toronto By-law 912-2020), City of Toronto By-law 845-2020, City of Toronto By-law 58-2021, is further amended by deleting section 3 and replacing it with the following:
 3. The above amendments, enacted and passed as City of Toronto By-law 322-2020 under Emergency Order No. 1 issued by Mayor John Tory, both dated April 2, 2020 and as extended by City of Toronto By-law 342-2020, City of Toronto By-law 666-2020 (as amended by City of Toronto By-law 912-2020), City of Toronto By-law 845-2020 and City of Toronto By-law 58-2021, are further extended by City Council at its June 8 and 9, 2021 meeting and remain in effect until 12:01 a.m. on the first day after the City Council meeting currently scheduled for September 30 and October 1, 2021 or, if that City Council meeting does not take place as scheduled, until 12:01 a.m. on the first day after the first City Council meeting that occurs after September 30 and October 1, 2021, unless further extended by City Council.
2. City of Toronto By-law 323-2020, as amended by City of Toronto By-law 342-2020, City of Toronto By-law 666-2020 (as amended by City of Toronto By-law 912-2020),

City of Toronto By-law 845-2020 and City of Toronto By-law 58-2021, is further amended by deleting section 2 and replacing it with the following:

2. The above amendment, enacted and passed as City of Toronto By-law 323-2020 under Emergency Order No. 2 issued by Mayor John Tory, dated April 3, 2020 and as extended by City of Toronto By-law 342-2020, City of Toronto By-law 666-2020 (as amended by City of Toronto By-law 912-2020), City of Toronto By-law 845-2020 and City of Toronto By-law 58-2021, is further extended by City Council at its September 30 and October 1, 2021 meeting and remains in effect until 12:01 a.m. on the first day after the City Council meeting currently scheduled for September 30 and October 1, 2021 or, if that City Council meeting does not take place as scheduled, until 12:01 a.m. on first day after the first City Council meeting that occurs after September 30 and October 1, 2021, unless further extended by City Council.
3. City of Toronto By-law 541-2020, as amended by City of Toronto By-law 664-2020, City of Toronto By-law 845-2020, City of Toronto By-law 58-2021, City of Toronto By-law 263-2021 and City of Toronto By-law 368-2021 is further amended by deleting section 9 and replacing it with the following:
 9. Each provision of this By-law, except section 7.1 which came into force on June 7, 2020, shall come into force 7 days after the date of enactment and each provision of this By-law, including section 7.1, is deemed to be no longer in effect and revoked at 12:01 a.m. on the first day after the City Council meeting currently scheduled for September 30 and October 1, 2021 or, if that City Council meeting does not take place as scheduled, until 12:01 a.m. on the first day after the first City Council meeting that occurs after September 30 and October 1, 2021, unless further extended by City Council.
4. City of Toronto By-law 664-2020, as amended by City of Toronto By-law 845-2020 and City of Toronto By-law 58-2021, is amended by deleting section 8 and replacing it with the following:
 8. This By-law shall come into force 7 days after the date of enactment and is deemed to be no longer in effect and revoked at 12:01 a.m. on the first day after the City Council meeting currently scheduled for September 30 and October 1, 2021 or, if that City Council meeting does not take place as scheduled, until 12:01 a.m. on the first day after the first City Council meeting that occurs after September 30 and October 1, 2021, unless further extended by City Council.
5. Section 354-3.11.A of City of Toronto Municipal Code Chapter 354, Apartment Buildings, is amended by deleting the phrase "until the City Council meeting currently scheduled for June 8 and 9, 2021 or, if that City Council meeting does not take place as scheduled, until 12:01 a.m. on the first day after the first City Council meeting that occurs after June 8 and 9, 2021, unless extended further by City Council" and replacing it with the phrase "until the City Council meeting currently scheduled for September 30 and October 1, 2021 or, if that City Council meeting does not take place as scheduled, until 12:01 a.m. on the first day after the first City Council meeting that occurs after September 30 and October 1, 2021, unless extended further by City Council".

6. Section 545-8.4.1.C.(3) of City of Toronto Municipal Code Chapter 545, Licensing, is deleted and replaced with the following:
- (3) is deemed to be no longer in effect and revoked at 12:01 a.m. on the first day after the City Council meeting currently scheduled for September 30 and October 1, 2021 or, if that City Council meeting does not take place as scheduled, until 12:01 a.m. on the first day after the first City Council meeting that occurs after September 30 and October 1, 2021, unless further extended by City Council.
