## CITY OF TORONTO

## BY-LAW 497-2021

To amend City of Toronto Municipal Code Chapter 910, Parking Machines and Meters, respecting Davenport Road.

Whereas City Council on April 7 and 8, 2021 adopted, as amended, Item IE20.13, wherein Attachment 5 to the report (March 22, 2021) from the General Manager, Transportation Services, recommended deleting Davenport Road south/west between Bay Street and a point 6.9 metres west of a point opposite the west curb of McMurrich Street, 9:30 a.m. to 3:30 p.m., Mon. to Fri.; 8:00 a.m. to 6:00 p.m. Sat., \$3.00 for 1 hour for a maximum of 3 hours; and

Whereas City Council at its meeting of April 7 and 8, 2021 enacted By-law 230-2021, being a by-law "To amend City of Toronto Municipal Code Chapter 910, Parking Machines and Meters, respecting Birmingham Street, Davenport Road, Richmond Street West" and deleted from Schedule 1 (Parking Machines) an entry for Davenport Road, inadvertently referring to the existing entry as "Bay Street and a point opposite the west curb of McMurrich Street"; and

Whereas pursuant to Section 169-5.2B of City of Toronto Municipal Code Chapter 169, Officials, City, the City Solicitor, in consultation with the City Clerk, may submit bills directly to Council to make technical amendments to the Municipal Code and other by-laws to correct technical errors, to update the by-laws to refer to the current statute, City official title, administrative unit and Municipal Code provision and to repeal by-laws of the former municipalities that have been superseded by provisions in the Municipal Code or as a result of an administrative reorganization;

The Council of the City of Toronto enacts:

1. Chapter 910, Parking Machines and Meters, is amended by deleting the following in alphabetical order in Schedule I, Parking Machines:
