## **BY-LAW 574-2021**

To amend City of Toronto Municipal Code Chapter 910, Parking Machines and Meters, respecting Merchants' Wharf.

The Toronto and East York Community Council enacts:

1. Chapter 910, Parking Machines and Meters, is further amended by inserting the following in alphabetical order in Schedule I, Parking Machines:

Merchants' Wharf (south leg)	North	A point 32 metres west of Merchants' Wharf (east leg) and a 43 metres further west	8:00 a.m. to 9:00 p.m., Mon. to Sun.	\$3.00 per hour	3 hours
