BY-LAW 574-2021

To amend City of Toronto Municipal Code Chapter 910, Parking Machines and Meters, respecting Merchants' Wharf.

The Toronto and East York Community Council enacts:

- Chapter 910, Parking Machines and Meters, is further amended by inserting the following in alphabetical order in Schedule I, Parking Machines:

(In Column 1 Highway)	(In Column 2 Side Parking)	(In Column 3 Between)	(In Column 4 Hours (daily as indicated below))	(In Column 5 Fee/Time Limit)	(In Column 6 Maximum Parking Period)
Merchants' Wharf (east leg)	East	A point 18.5 metres north of Merchants' Wharf (south leg) and a point 37.5 metres further north	8:00 a.m. to 9:00 p.m., Mon. to Sun.	\$3.00 per hour	3 hours
Merchants' Wharf (west leg)	East	A point 71 metres south of Queens Quay East and a point 58 metres further south	8:00 a.m. to 9:00 p.m., Mon. to Sun.	\$3.00 per hour	3 hours
Merchants' Wharf (east leg)	West	A point 9 metres north of Merchants' Wharf (south leg) and a point 18 metres further north	8:00 a.m. to 9:00 p.m., Mon. to Sun.	\$3.00 per hour	3 hours
Merchants' Wharf (east leg)	West	A point 53 metres north of Merchants' Wharf (south leg) and a point 20 metres further north	8:00 a.m. to 9:00 p.m., Mon. to Sun.	\$3.00 per hour	3 hours
Merchants' Wharf (south leg)	North	A point 20 metres east of Merchants' Wharf (west leg) and a point and a point 67 metres further east	8:00 a.m. to 9:00 p.m., Mon. to Sun.	\$3.00 per hour	3 hours
Merchants' Wharf (south leg)	North	A point 32 metres west of Merchants' Wharf (east leg) and a 43 metres further west	8:00 a.m. to 9:00 p.m., Mon. to Sun.	\$3.00 per hour	3 hours
