CITY OF TORONTO

BY-LAW 578-2021

To repeal By-law 103-2021, being a by-law to amend City of Toronto Municipal Code Chapter 910, Parking Machines and Meters, respecting Chisholm Avenue and Gough Avenue, and to amend City of Toronto Municipal Code Chapter 910, Parking Machines and Meters, respecting Chisholm Avenue and Gough Avenue.

Whereas Toronto and East York Community Council adopted Item TE23.67 and authorized entries for Gough Avenue and Chisholm Avenue to be inserted into Schedule I, Parking Machines, of City of Toronto Municipal Code Chapter 910, Parking Machines and Meters; and

Whereas the entry recommended to be inserted for Chisholm Avenue inadvertently referenced "Danforth Avenue to Harris Avenue" instead of "Danforth Avenue and Harris Avenue"; and

Whereas, pursuant to Item TE23.67, Toronto and East York Community Council enacted By-law 103-2021, being a by-law "To amend City of Toronto Municipal Code Chapter 910, Parking Machines and Meters, respecting Chisholm Avenue and Gough Avenue" wherein entries for Chisholm Avenue and Gough Avenue were deleted from instead of inserted into Schedule I, Parking Machines, of City of Toronto Municipal Code Chapter 910, Parking Machines and Meters; and

Whereas there were no such entries to delete from Schedule I, Parking Machines, in City of Toronto Municipal Code Chapter 910, Parking Machines and Meters; and

Whereas Section 169-5.2A of City of Toronto Municipal Code Chapter 169, Officials, City, authorizes the City Solicitor to process by-laws where an action is authorized by Council and if the recommendation to amend a by-law or introduce a bill has been omitted or if there is an error in the reference to the by-law that should be amended or if it is necessary to repeal a by-law; and

Whereas pursuant to Section 169-5.2B of City of Toronto Municipal Code Chapter 169, Officials, City, the City Solicitor, in consultation with the City Clerk, may submit bills directly to Council to make technical amendments to the Municipal Code and other by-laws to correct technical errors, to update the by-laws to refer to the current statute, City official title, administrative unit and Municipal Code provision and to repeal by-laws of the former municipalities that have been superseded by provisions in the Municipal Code or as a result of an administrative reorganization;

The Toronto and East York Community Council enacts:

1. By-law 103-2021 is repealed.

2. Chapter 910, Parking Machines and Meters, is amended by inserting the following in alphabetical order in Schedule I, Parking Machines:

(In Column 1 Highway)	(In Column 2 Side Parking)	(In Column 3 Between)	(In Column 4 Hours (daily as indicated below))	(In Column 5 Fee/Time Limit)	(In Column 6 Maximum Parking Period)
Chisholm Avenue	East	Danforth Avenue and Harris Avenue	8:00 a.m. to 6:00 p.m., Mon. to Fri.; 8:00 a.m. to 6:00 p.m., Sat.	\$2.00 for 1 hour	3 hours
Gough Avenue	East	A point 9 metres north of Danforth Avenue and a point 62 metres further north	8:00 a.m. to 9:00 p.m. Mon. to Sat.; 1:00 p.m. to 9:00 p.m., Sun.	\$3.00 for 1 hour	3 hours
