BY-LAW 653-2021

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Ava Road, Barrie Avenue, Davenport Road, Dundurn Crescent, Earlsdale Avenue, Eastern Avenue, Fairford Avenue, Gerrard Street East, Gloucester Grove, Hursting Avenue, Queen Street East, Shaw Street, Watford Avenue, Winona Drive and Woodfield Road.
