### BY-LAW 710-2021

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Alcorn Avenue, Ashdale Avenue, Beresford Avenue, Boon Avenue, Brock Avenue, Chilton Avenue, Chisholm Avenue, Emerson Avenue, Eversfield Road, Garnet Avenue, Golfview Avenue, Harrison Street, Humewood Gardens, Kent Road, Logan Avenue, Marjory Avenue, Prust Avenue, Rhodes Avenue, Seymore Avenue, Strickland Avenue, Whistle Post Street, Wallace Avenue and Wolverton Avenue.

The Toronto and East York Community Council enacts:

- 1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
- A. By deleting from Schedule II (Designated On-Street parking for Permit Holders), the following in alphabetical order by street name:
