**CITY OF TORONTO**

**BY-LAW 907-2021**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Evelyn Wiggins Drive.**

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
- A. By deleting from Schedule IV (Former City of North York Winter Maintenance Parking Prohibited) in § 950-1303, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)
Evelyn Wiggins Drive	Murray Ross Parkway and Assiniboine Road

- B. By inserting in Schedule IV (Former City of North York Winter Maintenance Parking Prohibited) in § 950-1303, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)
Evelyn Wiggins Drive (west side)	Murray Ross Parkway and Assiniboine Road

- C. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
