## BY-LAW 1072-2021

To amend City of Toronto Municipal Code Chapter 910, Parking Machines and Meters, respecting Dundas Street West.

Whereas City of Toronto Council on November 9, 10 and 12, 2021 adopted as amended Item TE28.35 and authorized entries for Dundas Street West to be inserted into Schedule I, Parking Machines, of City of Toronto Municipal Code Chapter 910, Parking Machines and Meters; and

Whereas Recommendation 11 was amended at Council but the by-law that was submitted and enacted, that being By-law 913-2021, being a by-law "To amend City of Toronto Municipal Code Chapter 910, Parking Machines and Meters, respecting Dundas Street West", inadvertently did not incorporate the amendments as made at Council; and

Whereas, pursuant to Section 169-5.2B of City of Toronto Municipal Code Chapter 169, Officials, City, the City Solicitor, in consultation with the City Clerk, may submit bills directly to Council to make technical amendments to the Municipal Code and other by-laws to correct technical errors, to update the by-laws to refer to the current statute, City official title, administrative unit and Municipal Code provision and to repeal by-laws of the former municipalities that have been superseded by provisions in the Municipal Code or as a result of an administrative reorganization;
