## CITY OF TORONTO

### BY-LAW 472-2022

#### **To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Cummer Avenue.**

Whereas City Council on April 7 and 8, 2021, adopted as amended Item IE20.13 wherein revised Attachment 5 to motion 1 by Councillor Jaye Robinson from the General Manager, Transportation Services authorized an entry for Cummer Avenue to be inserted into Schedule XIV: No Stopping, of City of Toronto Municipal Code Chapter 950, Traffic and Parking; and

Whereas City Council on April 8, 2021 enacted By-law 228-2021, being a by-law "To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Avenue Road, Birmingham Street, Bloor Street West, Brant Street, Cummer Avenue, Danforth Avenue, Davenport Road, Dundas Street West, Richmond Street West, Shaw Street, The Kingsway, Thorncliffe Park Drive." and incorrectly included the between entry as "Bayview Avenue and Pineway Boulevard" instead of "Pineway Boulevard and Leslie Street" in the 3rd column of the entry for Cummer Avenue; and

Whereas, pursuant to Section 169-5.2B of City of Toronto Municipal Code Chapter 169, Officials, City, the City Solicitor, in consultation with the City Clerk, may submit bills directly to Council to make technical amendments to the Municipal Code and other by-laws to correct technical errors, to update the by-laws to refer to the current statute, City official title, administrative unit and Municipal Code provision and to repeal by-laws of the former municipalities that have been superseded by provisions in the Municipal Code or as a result of an administrative reorganization;

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
  - A. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

B. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:
