

CITY OF TORONTO

BY-LAW 683-2022

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Boon Avenue, Clendenan Avenue, Craven Road, Emerson Avenue, Galt Avenue, Hanson Street, Hursting Avenue, Indian Grove, Nairn Avenue, Pacific Avenue, Rushton Road, Shudell Avenue and St. Johns Road.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
 - A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

Boon Avenue	East	A point 87.5 metres north of St. Clair Avenue West and a point 5.5 metres further north	Anytime
Boon Avenue	East	A point 20.5 metres south of Morrison Avenue and a point 5.5 metres further south	Anytime
Boon Avenue	West	A point 83.5 metres north of St. Clair Avenue West and a point 5.5 metres further north	Anytime
Boon Avenue	West	A point 22.0 metres south of Morrison Avenue and a point 5.5 metres south	Anytime
Craven Road	East	A point 51 metres north of Dundas Street East and a point 5.5 metres further north	Anytime
Emerson Avenue	East	A point 96.7 metres south of Paton Road and a point 5.5 metres further south	Anytime
Emerson Avenue	West	A point 96.7 metres south of Paton Road and a point 5.5 metres further south	Anytime
Pacific Avenue	South	A point 76.5 metres north of Humberside Avenue and a point 5.5 metres further north	Anytime

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time or Days)
Shudell Avenue	North	A point 16.5 metres east of Seymour Avenue and a point 5.5 metres further east	Anytime
St. Johns Road	South	A point 21 metres west of Windermere Avenue and a point 5.5 metres further west	Anytime

B. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	In Column 4 Time or Days)
Clendenan Avenue	East	A point 69.5 metres north of Annette Street and a point 5.5 metres further north	Anytime
Galt Avenue	West	A point 15 metres north of Gerrard Street East and a point 5.5 metres further north	Anytime
Galt Avenue	West	A point 20.5 metres north of Gerrard Street East and a point 5.5 metres further north	Anytime
Hanson Street	South	A point 48 metres east of Parkmount Road and a point 5.5 metres further east	Anytime
Hursting Avenue	North	A point 9.0 metres east of Winnett Avenue and a point 5.5 metres further east	Anytime
Hursting Avenue	South	A point 10.3 metres east of Winnett Avenue and a point 5.5 metres further east	Anytime
Indian Grove	West	A point 18.8 metres south of Bodwin Avenue and a point 5.5 metres further south	Anytime
Nairn Avenue	East	A point 16.5 metres south of Rodgers Road and a point 5.5 metres further south	Anytime
