CITY OF TORONTO

BY-LAW 1026-2022

To dedicate certain lands located to the northeast quadrant of Eglinton Avenue East and Midland Avenue for temporary public highway purposes.

Whereas the City anticipates it will be granted a lease for temporary public highway purposes from Metrolinx pursuant to notice of lease registered in the Land Registry Office for Toronto (No. 66);
