CITY OF TORONTO

BY-LAW 1129-2022

To amend City of Toronto Municipal Code Chapter 918, Parking on Residential Front Yards and Boulevards, to more specifically amend section 918-3A to reflect the correct Zoning By-law number.

Whereas City Council at its meeting on April 6 and 7, 2022 adopted Item IE28.9 wherein it was recommended that Section 918-3A of City of Toronto Municipal Code Chapter 918, Parking on Residential Front Yards and Boulevards, be amended; and

Whereas Recommendation 1b of Item IE28.9 referenced the Zoning By-law in one part of the recommendation inadvertently as being Zoning By-law 596-2013 and in another portion of the same recommendation correctly as Zoning By-law 569-2013; and

Whereas on April 7, 2022 City Council adopted By-law 313-2022, being a by-law "To amend City of Toronto Municipal Code Chapter 918, Parking on Residential Front Yards and Boulevards, to more specifically amend section 918-3A and section 918-6"; and

Whereas By-law 313-2022 inadvertently amended section 918-3A of Chapter 918 to reference Zoning By-law 596-2013 instead of Zoning By-law 569-2013; and

Whereas pursuant to section 169-5.2A of City of Toronto Municipal Code Chapter 169, Officials, City, the City Solicitor may process by-laws where an action is authorized by Council and if the recommendation to amend a by-law or introduce a bill has been omitted or if there is an error in the reference to the by-law that should be amended or if it is necessary to repeal a by-law; and

Whereas pursuant to section 169-5.2B of City of Toronto Municipal Code Chapter 169, Officials, City, the City Solicitor, in consultation with the City Clerk, may submit bills directly to Council to make technical amendments to the Municipal Code and other by-laws to correct technical errors, to update the by-laws to refer to the current statute, City official title, administrative unit and Municipal Code provision and to repeal by-laws of the former municipalities that have been superseded by provisions in the Municipal Code or as a result of an administrative reorganization;

The Council of the City of Toronto enacts:

1. Section 918-3A of City of Toronto Municipal Code Chapter 918, Parking on Residential Front Yards and Boulevards, is amended by deleting the phrase "Zoning By-law 596-2013" and inserting the phrase "Zoning By-law 569-2013".
