- F. By inserting a new Subsection (9) in § 950-1202A as follows:
 - "(9) During the time frame indicated in the entry in Subsection 1A to 1E, inclusive, of By-law 1115-2023, the provisions of Subsections 1A to 1E of By-law 1115-2023 shall apply notwithstanding anything to the contrary in any other by-law or chapter of the Municipal Code. For further clarity, where any regulation contained in Subsection 1A to 1E, inclusive, of By-law 1115-2023 conflicts with any other regulation in any Schedule of the Municipal Code Chapter 950, Traffic and Parking, the regulation as found in By-law 1115-2023 shall prevail during the time frame outlined in the regulation as found in By-law 1115-2023."
