CITY OF TORONTO

BY-LAW 309-2024

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Gilbert Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
 - A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time or Days)
Beaconsfield Avenue	East	A point 52.5 metres south of Mackenzie Crescent and a point 5.5 metres further south	Anytime from the 1st day to the 15th day of each month from Apr. 1 to Nov. 30, inclusive, and from Dec. 1 of one year to Mar. 31 of the next following year, inclusive
Beaconsfield Avenue	West	A point 42.3 metres north of Cross Street and a point 5.5 metres further north	Anytime from the 16th day to the last day of each month from Apr. 1 to Nov. 30, inclusive
Cosburn Avenue	North	A point 42.5 metres east of Woodbine Avenue and a point 5.5 metres further east	Anytime
Eastwood Road	North	A point 28 metres west of Bowmore Road and a point 5.5 metres further West	Anytime
Greenwood Avenue	East	A point 48 metres north of Cherry Nook Gardens and a point 5.5 metres further	Anytime
Gilmour Avenue	West	A point 73 metres north of Annette Street and a point 5.5 metres further north	Anytime

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time or Days)
Nairn Avenue	East	A point 14.5 metres south of Ascot Avenue and a point 5.5 metres further south	The first day to the 15th day of each month, from Apr. 1 to Nov. 30, inclusive
Sunnyside Avenue	East	A point 22.5 metres north of Grenadier Road and a point 5.5 metres further north	Anytime
Wolfrey Avenue	North	A point 66 metres west of Bowden Street and a point 5.5 metres further West	Anytime

A. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

Ashdale Avenue	East	A point 74 metres north of Fairford Avenue and a point 5.5 metres further north	Anytime
Havelock Street	West	A point 16 metres north of College Street and a point 5.5 metres further north	Anytime
Hepbourne Street	South	A point 43 metres west of Rusholme Road and a point 5.5 metres further west	Anytime
Hiawatha Road	East	A point 116 metres south of Gerrard Street East and a point 5.5 metres further south	Anytime
Lee Avenue	West	A point 41 metres south of Juniper Avenue and a point 5.5 metres further south	Anytime
Nairn Avenue	East	A point 20 metres south of Ascot Avenue and a point 5.5 metres further south	First day to the 15th day of each month, from Apr. 1 to Nov. 30, inclusive

Selkirk Street	North	A point 39.3 metres west of Woodycrest Avenue and a point 5.5 metres further west	Anytime

Woodfield Road	East	A point 34 metres north of Walpole Avenue and a point 5.5 metres further north	Anytime
