CITY OF TORONTO

BY-LAW 623-2024

To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to reflect the amended boundaries of Historic Queen East Business Improvement Area.

Whereas the City of Toronto Municipal Code Chapter 19, Business Improvement Areas designates various areas of the City as Business Improvement Areas, including the Historic Queen East Business Improvement Area; and

Whereas by the enactment of By-law 623-2024 on June 26 and 27, 2024, City Council designated an area that includes the existing area of the Historic Queen East Business Improvement Area (as described in By-law 836-2006) as an improvement area; and

Whereas Schedule A of Chapter 19, Business Improvement Areas, must be amended to reflect the designation of the amended area of the Historic Queen East Business Improvement Area;

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
 - a. the table in Schedule A of Municipal Code Chapter 19, Business Improvement Areas, is amended by deleting By-law "836-2006" beside the name " Historic Queen East " in the "Designating By-law (Former Municipality)" column and substituting "623-2024"; and
 - b. Schedule A, Maps is amended by deleting the maps of the Historic Queen East Business Improvement Area and substituting the maps of the Historic Queen East Business Improvement Area attached to this by-law.

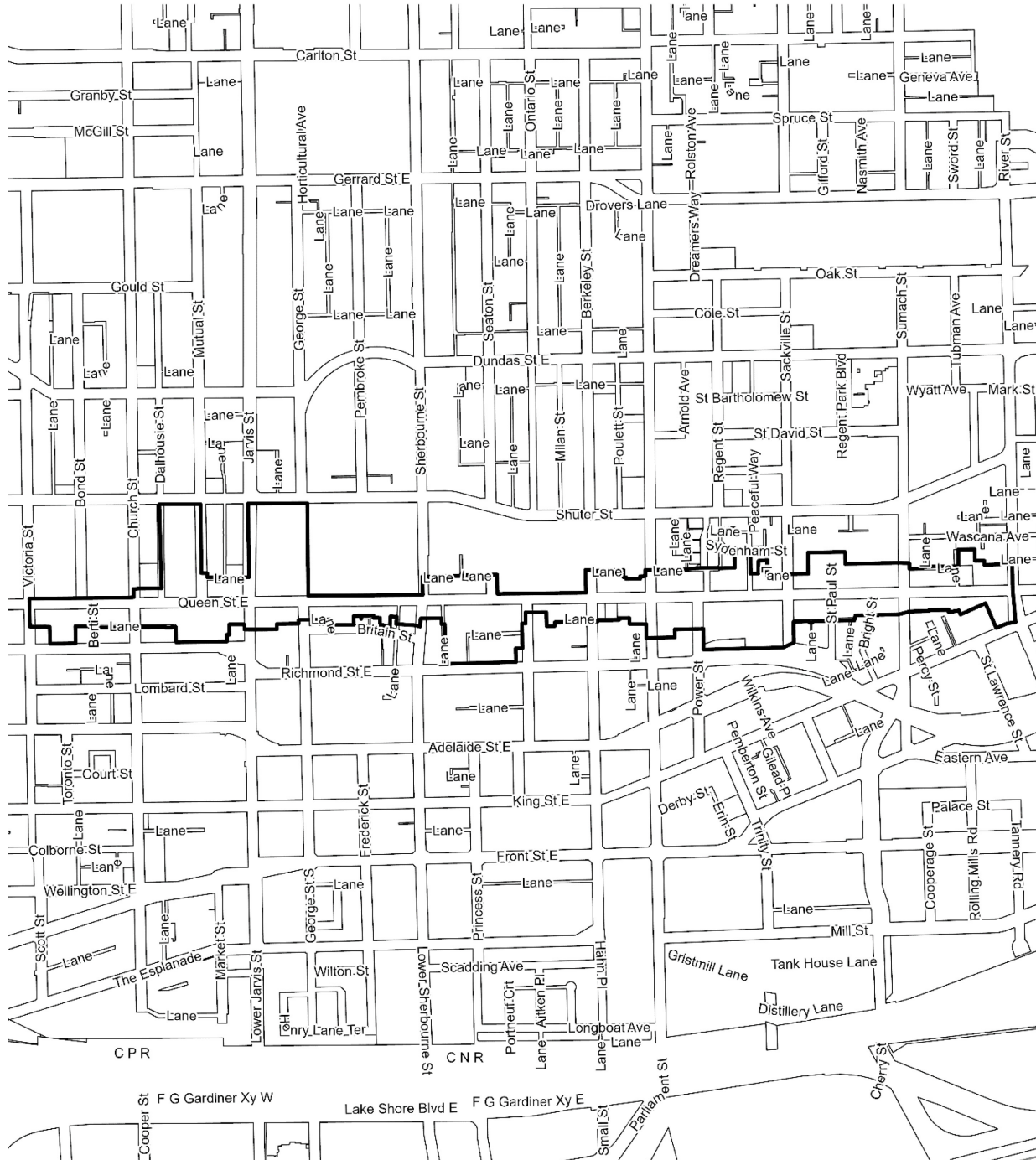
