CITY OF TORONTO

BY-LAW 27-2025

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Crawford Street, Ellerbeck Street, Gladstone Avenue, Kingsmount Park Road, Humberside Avenue, Huron Street, Montrose Avenue, Page Street, Waverly Road and Windermere Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
 - A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time or Days)
Crawford Street	West	A point 78 metres north of Queen Street West and a point 5.4 metres further north	Anytime
Ellerbeck Street	East	A point 11 metres north of Butternut Street and a point 5.5 metres further north	From the 1st day to the 15th day of each month from Apr. 1 to Nov. 30, inclusive
Ellerbeck Street	West	A point 15 metres north of Butternut Street and a point 5.5 metres further north	From Dec. 1 of one year to Mar. 31 of the next following year, inclusive, and from the 16th day to the last day of each month from Apr. 1 to Nov. 30, inclusive
Kingsmount Park Road	East	A point 33.5 metres south of Fairmount Crescent and a point 5.5 metres further south	Anytime
Windermere Avenue	East	A point 75.5 metres south of Annette Street and a point 5.5 metres further south	Anytime

B. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Gladstone Avenue	East	A point 24 metres south of Dupont Street and a point 5.5 metres further south	Anytime
Humberside Avenue	North	A point 106 metres west of Dundas Street West and a point 5.5 metres further west	Anytime
Huron Street	East	A point 90 metres south of Bernard Avenue and a point 5.5 metres further north	Anytime
Montrose Avenue	East	A point 17.5 metres south of Sully Crescent and a point 5.5 metres further south	Anytime, from the first day to the 15th day of each month, from Apr. 1 to Nov. 30, inclusive
Montrose Avenue	West	A point 18.5 metres south of Sully Crescent and a point 5.5 metres further south	Anytime, from Dec. 1 of one year to Mar. 31 of the next following year, inclusive, and from the 16th day to the last day of each month from Apr. 1 to Nov. 30, inclusive
Page Street	North	A point 5.5 metres east of Jersey Avenue and a point 5.5 metres further east	Anytime
Waverley Road	East	A point 187.3 metres south of Norway Avenue and a point 5.5 metres further south	Anytime
