BY-LAW 78-2025

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, and City of Toronto Municipal Code Chapter 610, Penalties, Administration of, in relation to pedestrian crossovers.

The Council of the City of Toronto enacts:

- 1. A. City of Toronto Municipal Code Chapter 950, Traffic and Parking, is amended by deleting Subsection (3) of §950-400B and inserting a new Subsection (3) as follows:
 - "(3) (a) Within 15 metres of a pedestrian crossover on the approach side to a pedestrian crossover;
 - (b) Within 10 metres of a pedestrian crossover beyond the crossover; or
 - (c) Where authorized signs are otherwise posted on the approach side of a pedestrian crossover or beyond a pedestrian crossover, within the area designated as no stopping by the authorized signs."
 - B. City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended by deleting Subsection (4) of §903-6A and inserting a new Subsection (4) as follows:
 - "(4) (a) Within 15 metres of a pedestrian crossover on the approach side to a pedestrian crossover;
 - (b) Within 10 metres of a pedestrian crossover beyond the crossover; or
 - (c) Where authorized signs are otherwise posted on the approach side of a pedestrian crossover or beyond a pedestrian crossover, within the area designated as no stopping by the authorized signs."
 - C. City of Toronto Municipal Code Chapter 610, Penalties, Administration of, is amended as follows:

a. By deleting from Schedule A, Table 10: Chapter 950, Traffic and Parking, the following:

2. Section 1 of this By-law shall take effect on February 10, 2025.
