## **CITY OF TORONTO**

### **BY-LAW 131-2025**

#### **To amend City of Toronto Municipal Code Chapter 925, Permit Parking, respecting Raglan Avenue.**

The Toronto and East York Community Council enacts:

- 1.** Municipal Code Chapter 925, Permit Parking, is amended as follows:
- A.** By deleting from Schedule A (Permit Parking), the following in alphabetical order by street name:

(From Column 1 Street)	(From Column 2 Side)	(From Column 3 Location)	(From Column 4 Period)	(From Column 5 Time)
Raglan Avenue	Even	From 14 Raglan Avenue to a point 130 meres south of Maplewood Avenue	All times, except no parking from 7:00 p.m. 1st day to 7:00 p.m. on the 16th day of each month, inclusive, Apr. 1 to Dec. 1, inclusive	12:00 midnight to 6:00 a.m.
Raglan Avenue	Odd	From 9 Raglan Avenue to a point 130 meres south of Maplewood Avenue	All times, except no parking from 7:00 p.m. on the 16th day of each month to 7:00 p.m. on the 1st day of each month, inclusive, April 1 to December 1, inclusive and no parking anytime from 7:00 p.m. December 1 of one year to 7:00 p.m. April 1 of the next following year, inclusive	12:00 midnight to 6:00 a.m.

B. By inserting in Schedule A (Permit Parking), the following in alphabetical order by street name:

(In Column 1 Street)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Period)	(In Column 5 Time)
Raglan Avenue	Even	From a point 123 metres north of St. Clair Avenue West to a point 130 metres south of Maplewood Avenue	All times, except no parking from 7:00 p.m. 1st day to 7:00 p.m. on the 16th day of each month, inclusive, Apr. 1 to Dec. 1, inclusive	12:00 midnight to 6:00 a.m.
Raglan Avenue	Odd	From a point 123 metres north of St. Clair Avenue West to a point 130 metres south of Maplewood Avenue	All times, except no parking from 7:00 p.m. on the 16th day of each month to 7:00 p.m. on the 1st day of each month, inclusive, April 1 to December 1, inclusive and no parking anytime from 7:00 p.m. December 1 of one year to 7:00 p.m. April 1 of the next following year, inclusive	12:00 midnight to 6:00 a.m.
