## CITY OF TORONTO

### BY-LAW 133-2025

**To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Balfour Avenue, Beech Avenue, Condor Avenue, Heintzman Street, King Edward Avenue, Kingswood Road, Lauder Avenue, Lauder Avenue, Lee Avenue, MacDonell Avenue, Pickering Street, Seaton Street, Sproat Avenue and Woodmount Avenue.**

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
  - A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time or Days)
Fernwood Park Avenue	West	A point 43 meters south of Hazel Avenue and a point 5.5 metres further south	Anytime
Lee Avenue	West	A point 41 metres south of Juniper Avenue and a point 5.5 metres further south	Anytime
St. Johns Road	South	A point 23 metres west of Beresford Avenue and a point 5.5 metres further west	Anytime

- B. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Balfour Avenue	North	A point 20.8 metres east of Palmer Avenue and a point 5.5 metres further east	Anytime

Beech Avenue	West	A point 57 metres north of Fir Avenue and a point 5.5 metres further north	Anytime
Condor Avenue	East	A point 69 metres north of Boulton Avenue and a point 5.5 metres further north	Anytime
Heintzman Street	East	A point 57 metres north of Dundas Street West and a point 5.5 metres further north	Anytime
King Edward Avenue	East	A point 283 metres south of Burrell Avenue and a point 5.5 metres further south	Anytime
Kingswood Road	West	A point 18.5 metres north of Queen Street East and a point 5.5 metres further north	Anytime
Lauder Avenue	West	A point 38.5 metres south of Genessee Avenue (north intersection) and a point 5.5 metres further south	Anytime, from the 16th day to the last day of each month, from Apr. 1 to Nov. 30, inclusive, and anytime, from Dec 1 of one year to Mar. 31 of the next following year, inclusive
Lauder Avenue	East	A point 27.5 metres south of Genessee Avenue (south intersection) and a point 5.5 metres further south	Anytime, from the 1st day to 15th day of each month, from Apr. 1 to Nov. 30, inclusive
Lee Avenue	West	A point 51 metres south of Juniper Avenue and a point 5.5 metres further south	Anytime
MacDonell Avenue	West	A point 85 metres south of Rideau Avenue and a point 5.5 metres further south	Anytime
Pickering Street	East	A point 27.8 metres north of Lyall Avenue and a point 5.5 metres further north	Anytime

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Seaton Street	West	A point 33.5 metres north of Gerrard Street East and a point 5.5 metres further north	Anytime
Sproat Avenue	North	A point 49 metres east of Jones Avenue and a point 5.5 metres further east	Anytime
Woodmount Avenue	East	A point 32 metres south of Springdale Boulevard and a point 5.5 metres further south	Anytime
