## **BY-LAW 327-2025**

To amend City of Toronto Municipal Code Chapter 441, Fees and Charges, to update solid waste fees and charges by deleting discontinued user fees.

The Council of the City of Toronto enacts:

- 1. Municipal Code Chapter 441, Fees and Charges, is amended by deleting from Appendix A (Schedule 1, Solid Waste Management Services) the fees and charges identified in Schedule A to this By-law.
- 2. The amendments to Appendix A (Schedule 1, Solid Waste Management Services) of Municipal Code Chapter 441, Fees and Charges, provided for in this By-law shall come into force upon enactment of this By-law.
