## BY-LAW 691-2025

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Bain Avenue, Barton Avenue, Carlton Street, Duvernet Avenue, Fern Avenue, First Avenue, Jerome Street, Mountjoy Avenue and Somerset Avenue.

The Toronto and East York Community Council enacts:

- 1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
- A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time or Days)
Carlton Street	South	A point 60 metres east of Parliament Street and a point 5.5 metres further east	Anytime
Duvernet Avenue	North	A point 9 metres east of Bellhaven Road and a point 5.5 metres further east	Anytime from the 16th day to the last day of each month from Apr. 1 to Nov. 30, inclusive
Duvernet Avenue	South	A point 10 metres east of Bellhaven Road and a point 5.5 metres further east	Anytime from Dec. 1 of one year to Mar. 31 of the next following year inclusive, and from the 1st day to the 15th day of each month from Apr. 1 to Nov. 30, inclusive
First Avenue	South	A point 9 metres east of Logan Avenue and a point 5.5 metres further east	Anytime
Mountjoy Avenue	North	A point 20 metres west of Parkmount Road and a point 5.5 metres further west	Anytime

B. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Bain Avenue	South	A point 103 metres west of Logan Avenue and a point 5.5 metres further west	Anytime
Barton Avenue	North	A point 9 metres west of Clinton Street and a point 5.5 metres further west	Anytime
Fern Avenue	South	A point 121 metres east of Sorauren Avenue and a point 5.5 metres further east	Anytime
Jerome Street	North	A point 67 metres east of Indian Road and a point 5.5 metres further east	Anytime
Somerset Avenue	East	A point 149 metres north of Geary Avenue and a point 8.5 metres further north	Anytime
