BY-LAW 779-2025

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Emerson Avenue.

The Council of the City of Toronto enacts:

- **1.** Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
