CITY OF TORONTO

BY-LAW 577-2026

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Beatrice Street, Craven Road, Dundas Street East, Glebeholme Boulevard, Haslett Avenue, Hertle Avenue, Osborne Avenue, Shaw Street and Stanhope Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
 - A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time or Days)
Osborne Avenue	East	A point 85 metres north of Lyall Avenue and a point 5.5 metres further north	Anytime

- B. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Beatrice Street	East	A point 180 metres south of College Street and a point 5.5 metres further south	First day to the 15th day of each month, from Apr. 1 to Nov. 30, inclusive and Dec. 1 of one year to Mar. 31 of the next following year, inclusive

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Beatrice Street	West	A point 186 metres south of College Street and a point 5.5 metres further south	16th day to the last day of each month, from Apr. 1 to Nov. 30, inclusive
Craven Road	East	A point 132.5 metres north of Dundas Street East and a point 5.5 metres further north	Anytime
Dundas Street East	South	A point 15 metres east of Curzon Street and a point 5.5 metres further east	Anytime
Glebeholme Boulevard	South	A point 19 metres east of Greenwood Avenue and a point 5.5 metres further east	Anytime
Haslett Avenue	West	A point 50 metres south of Kingston Road and a point 5.5 metres further south	Anytime
Hertle Avenue	West	A point 77.5 metres north of Dundas Street East and a point 5.5 metres further north	Anytime
Shaw Street	West	A point 9 metres north of Barton Avenue and a point 5.5 metres further north	Anytime
Stanhope Avenue	East	A point 78 metres north of O'Connor Drive and a point 5.5 metres further north	Anytime during the months of Jan., Feb., Mar., Apr., Jun., Aug., Oct. and Dec.
Stanhope Avenue	West	A point 73 metres north of O'Connor Drive and a point 5.5 metres further north	Anytime during the months of May, Jul., Sep. and Nov.
