SUMMARY

The purpose of this report is to present the 2006 audited financial statements of twentyeight Business Improvement Areas (BIAs) operated by Boards of Management and related audit management letters to the members of the Audit Committee.

The twenty-eight financial statements along with appropriate management letters attached to this report have been approved by the Boards of Management of BIAs. Financial statements for the remaining twenty-six BIAs are either in the process of being prepared, audited, awaiting responses to audit management letters or being held pending Board approval. These remaining financial statements and management letters, upon completion of their respective audits and Board approval, will be tabled for information by the members of the Audit Committee.

Financial Impact

There are no financial implications resulting from this report.

The Deputy City Manager and Chief Financial Officer has reviewed this report and agrees with the financial impact information.

DECISION HISTORY

Every year, members of individual BIAs approve its budget at their respective Annual General Meeting and submit it to City Council for approval. For financial reporting purposes, BIAs are classified as Government Organizations where its expenditures include capital and operating expenses.

In accordance with City of Toronto By-law 683-2003, each individual BIA Board is required to approve and submit its audited financial statements annually to members of the Audit Committee at the end of each year.

ISSUE BACKGROUND

Of the twenty-eight management letters received, the issues identified in this report relate specifically to Queens Quay Harbourfront BIA and include the following:

- BIA maintaining large amounts of cash in the current bank accounts earning minimum interest;
- BIA paying remuneration to the Executive Director without any statutory deductions; and
- No insurance coverage for Directors' and Officers' liability.

COMMENTS

The Management at Queens Quay Harbourfront BIA has taken the following actions in response to issues identified in the management letter:

- The new Treasurer at the BIA has now invested all excess cash not immediately required into cashable short-term investments;
- The Executive Director's employment contract is under review and BIA has advised legal counsel to take into consideration all employment aspects including requirements of the Canada Revenue Agency; and
- The BIA has now obtained insurance coverage for Directors' and Officers' liability insurance.
