December 5, 2006

The Members of Council of the City of Toronto, for the four-year term commencing December 1, 2006, met on Tuesday, December 5, 2006, at 2:00 p.m. in the Council Chamber, City Hall, Toronto.

The City Clerk, Ulli S. Watkiss, presided in accordance with the provisions of the *Municipal Act*, 2001.

The meeting opened with the singing of the National Anthem by Ms. Simone Soman.

Council rose and observed a moment of silence and personal reflection.

1.1 CONFIRMATION OF ELECTION RESULTS

The City Clerk welcomed the Members of Council to the First Meeting of the Council of the City of Toronto, and reported that she had declared the 2006 Municipal Election results, as to the persons elected and entitled to be Members of the Council of the City of Toronto, for a four-year term of office starting on December 1, 2006.

On behalf of the City Manager and the Toronto Public Service, the City Clerk extended her congratulations to Mayor David Miller and the Members of Council.

- 3. Debenture financing not to exceed \$109.719 million (for New and Change in Scope, and Previously Approved Projects) with a term not exceeding the lesser of 10 years or the useful life of the capital assets, be approved.
- 4. City Council authorize other financing sources for New and Change in Scope and Previously Approved Projects as follows: Reserves/Reserve Funds in the amount of \$114.783 million, Development Charges in the amount of \$5.162 million and other financing source in the amount of \$124.377 million.

His Worship, Mayor David Miller's First Meeting Address – December 5, 2006

Members of Council, Chief Justice McMurtry, fellow Torontonians.

Good afternoon.

I would like to begin by welcoming back the returning Members of Council and congratulate those of you who are sitting in this Chamber for the first time. Serving the public is one of the noblest callings anyone can undertake.

It's not always glamourous and it's certainly not easy. But the sense of satisfaction and the feeling of reward in knowing that you are making a real difference to the people of this City is like no other.

I stand before you today immensely privileged, honoured and more than a little humbled to serve as Mayor of our great City once again.

The people of Toronto have given me a clear, and strong, mandate. And I would like to spend a few minutes – yes a few – sharing it with you and outlining how over the next four years, we will deliver it.

My commitment to Torontonians was based on three key principles: Toronto must be a City that brims with prosperity, liveability and opportunity for all.

Achieving that, though, is going to require all of us to work together in the best traditions of municipal government.

Three years ago we began to change our City Government. I'm proud of the gains we have made.

Over the next four years I will use my Office to continue bringing about real change and real progress. To that end, I have already directed senior City staff to develop strategies to implement my mandate. Work is well underway.

My commitment is to a prosperous, inclusive City that is safe, economically strong, clean and green, transit friendly, creative and a place where everyone has a chance to succeed.

A week and a half ago, I was pleased to join Prime Minister Harper and Premier McGuinty in supporting the federal government's plans for a reverse onus bail system for those involved in gun crimes.

It was a significant moment because the reform is something that we had been calling for

and something I committed to seeing happen in this term – it is right at page 3 of my mandate!

Consider too, that by the end of this month, 450 more police officers will be on the streets of Toronto, working with communities to prevent crime and put criminals in jail.

But to be truly safe, a City must invest in its youth to ensure that every young person has the hope of a bright future.

We must build on the success of the Mayor's Community Safety Plan by building new partnerships in our 13 priority neighbourhoods, using the new funding I have committed to help build these partnerships.

The second area I want to address is that of a strong economy.

In the last three years, we've kept property tax increases at a reasonable level in line with inflation and that is my commitment for the next four.

We created a lower tax rate for small, neighbourhood-based businesses. And we've grown the economic clusters that will deliver the jobs of tomorrow.

We fought for better funding and a fair shake from the other orders of government. We've partnered with labour and business to make a powerful case for change.

We must be a City that spends for impact while living within our means.

But to be able to live within our means, we need sustainable funding. Obtaining that funding needs leadership from this Council which I will address shortly.

The third pillar is making our City a green leader.

We're already the national leaders in diverting waste from landfill and I want to go even further. I'm determined to increase our diversion rate to 70 percent by 2010.

I want to cut smog pollutants in the air we breathe by 20 percent within six years. We'll implement a tough anti-smog plan, and we'll develop a climate change program for Toronto.

We are already recognized for our Green initiatives but now is not the time to grow complacent. Where national governments have failed to lead, cities must lead.

And as Canada's biggest City we have an opportunity to lead by tremendous example. Reducing green house gases is THE issue of our time. Maybe of all time.

A climate change strategy is so critical to the future of Toronto that it will be overseen by

the Executive Committee supported by the Parks and Environment Committee.

One way we can begin to clear the air is to get people out of their cars. If we plan properly and give people REAL alternatives to their cars, not only will our air be cleaner, but our streets will be less congested.

Which brings me to my fourth point: public transit.

We have a great transit system for a City of 1.5 million people. But Toronto is now home to 2.6 million — and that number is expected to grow in the coming decades.

We can't have all those people driving cars.

However, providing real transit alternatives is not easy or cheap.

With dedicated rights-of-way like the one on St. Clair, we can turn a streetcar into an above ground subway at about a tenth of the cost and bring rapid transit to all parts of the city in the process. To Northern Scarborough and Northern Etobicoke...areas where residents have, for too long, relied on multiple bus transfers to do the most basic of things like getting to work or going shopping.

But that's just the beginning. We should be thinking big. That means working with other governments to develop a National Transit Strategy and with the GTTA to develop a region wide strategy, recognizing that Toronto, and the TTC, are at the core of this region's mobility.

The fifth area we will focus on is building on Toronto's strengths as one of the world's most creative cities.

We have some of incredible world-stature cultural institutions - the ROM, the AGO, the Toronto International Film Festival, our live theatre scene to name a few. We can build on that and we must absolutely bring back Nuit Blanche - an unforgettable event that showed the world and ourselves just how far the arts have come in our great City.

Most importantly, we must ensure Toronto is a City of opportunity for all...a City where no one is left behind.

In my Toronto, building prosperity is a shared dream and fighting despair a shared duty for all of us.

Housing is a basic Human Right. We must create 1,000 affordable housing units each year for the next four years.

This Council must lead the campaign to maintain funding for affordable housing through the Sustainable Communities Partnership Initiative or SCPI.

That program is set to expire in March and without it, all the good work we've been doing could be undone in the blink of an eye.

I also want to see people in every community have a chance to reach their full potential.

By investing in neighbourhoods that for too long were marginalized and by giving the young people in those communities a real chance for education and employment, we ensure nobody is excluded, and that every Torontonian is valued.

What I have spoken about today is the vision that the overwhelming majority of Torontonians supported when they re-elected me; a vision that sees a great city built neighbourhood by neighbourhood.

Fellow Members of Council, I now want to speak to you about how we do the job we have been entrusted to do and how we overcome the greatest obstacle and insufficient support from Ottawa and Queen's Park.

Our mission is clear, our mandate is strong and it is incumbent on all of us to work together to deliver what this City needs to succeed.

We will at times disagree over some details, but that disagreement should never stop us from working together to achieve the goal we all share.

I want to be clear. We all have a role in ensuring Toronto's success and I promise you today, I will fulfill mine with vigour and tireless commitment.

That is my promise to you. I ask for your commitment as well.

This is a special time in Toronto's history. The new *City of Toronto Act*, and our new governance structure, for the first time recognize Toronto's status as Canada's sixth largest government, one larger than most provinces.

This confers new opportunities, new powers on this Council – but also new responsibilities. And we need to rise to the challenge, to ensure that this Chamber becomes a place of enlightened policy debate, befitting the City's new status.

We are the trailblazers and it's my intention to make the transition as meaningful as possible. We must seize this opportunity to make the changes befitting Canada's 6th largest government.

Led by the Executive Committee, the new Standing Committees and City staff will do the work of implementing the policies of this Council.

Meanwhile some of the more local, day-to-day matters will become the responsibility of

the Community Councils.

My hope is that with this new structure will come a new, more thoughtful and higher level of debate in this Chamber.

This is our chance to reform the way we treat each other and the way others perceive us. I have confidence that this Council will be up to that challenge.

I look forward to working with you; with all of you to that end.

We start well. We are all united in the need for a New Deal.

Pursuing that goal is our most pressing and immediate mission. We all recognize the City cannot continue to pay for the responsibilities of other governments that were downloaded over the last decade.

We have received a strong mandate to tell the Premier and the Prime Minister that Toronto needs a one-cent share of the existing sales tax — and that we won't take no for an answer. It's what we need to build our City.

I will be asking all Members of this Council, all Torontonians to join me in a campaign to ensure that the municipal fiscal imbalance is addressed, that the federal government creates a national transit strategy and we obtain a share of revenues that grow with the economy.

What it will take is a concerted effort by all of us to remind our MPs and MPPs that when Toronto succeeds, Ontario succeeds and when cities succeed, Canada succeeds.

As things stand now, Toronto is set up to fail because those governments have our money.

Our friends at Queen's Park and in Ottawa don't need us to remind them that within a year they are all facing re-election. In each election there will 23 seats that Toronto voters will have a say in filling.

The candidates and parties that put forward the best platform for Toronto and for cities will be rewarded. Those that ignore Toronto, do so at their peril.

The Conference Board of Canada has said that if just 10 percent of the \$11 billion in taxes that leaves Toronto every year stayed here, we would have access to good roads, dependable transit, community services, clean, safe neighbourhoods, and all of the other services Torontonians expect from their city government.

What we are seeking is not a bailout, it is not a handout. It's our money!

And when we succeed, not if, we will able to make the kinds of investments that are absolutely vital to Toronto's success, to Ontario's success and to the success of our

country.

We've already had some successes:

Other governments are sharing a portion of the gas tax with us.

And three years ago, who thought that we'd have a new City of Toronto Act?

We were successful in making those gains because Torontonians spoke with one voice.

We must unite again.

I can't emphasize enough the opportunity we have been given. The *City of Toronto Act*, our governance changes and a longer term allow us to dream about a better Toronto.

A New Deal and the funding that comes with it will make that dream reality.

Thank you and now let's get to work.
