Review of Winterlicious and Summerlicious Program Criteria

(February 1, 2007) report from the General Manager, Economic Development, Culture and Tourism.

Financial Impact

There are no financial implications resulting from the adoption of this report.

Summary

This report addresses two notices of motion pertaining to the Winterlicious and Summerlicious restaurant promotions: the participation of restaurants in the Scarborough area and a review of opportunities for inclusion of restaurants that meet the Council-approved criteria but have multiple venues.

The two motions were considered by staff in consultation with the Ontario Hotel, Motel & Restaurant Association (OHMRA) and the processes were reviewed. In order to sustain the integrity of the programs the current criteria and process must be maintained.

All restaurants in all Wards of Toronto that meet the Winterlicious and Summerlicious criteria are invited to participate in the promotion. Restaurants wishing to be considered for the program should consult with the three rating publications used to determine program participation to find out how they might have their restaurant reviewed and/or receive a higher rating.

The program criteria also designates that participating restaurants must offer a unique dining experience. Multi-venue restaurants are permitted to participate, however restaurants that are part of a branded chain, offering the same menu, the same atmosphere and the same experience at each of the chain locations, are not eligible for participation in the program.

Staff will continue to consult and seek advice from the OHMRA and provide an online information page for restaurants to review to learn more about the criteria and how to be included.

New Municipal Code Chapter 19 - Business Improvement Areas

(March 19, 2007) report from the General Manager, Economic Development, Culture and Tourism.

Recommendations

The General Manager of Economic Development, Culture and Tourism recommends that:

- 1. Council adopt a new City of Toronto Municipal Code, Chapter 19, "Business Improvement Areas" generally in accordance with Attachment No. 1;
- 2. Council dissolve all existing Business Improvement Area Boards, as listed in Attachment No. 2, and re-establish them as City boards under Section 141 of the Act;
- 3. Council delegate to the appropriate community councils the authority to establish new BIA Boards following the designation of the BIA, unless the BIA is located within the boundaries of more than one community council, in which case new BIA Boards shall continue to be established by Council;

- 4. Municipal Code Chapter 27, Council Procedures, be amended to delegate to the community councils the authority to establish new BIA Boards unless the BIA is located within the boundaries of more than one community council; and
- 5. authority be granted to the City Solicitor to submit any bills required to enact the new Municipal Code Chapter 19 and to amend Municipal Code Chapter 27, generally in accordance with the report recommendations and Attachment No. 1 of this report, subject to any necessary refinements, including stylistic, format and organization, as may be identified by the City Solicitor and City Clerk, and any other bills required to give effect to these recommendations.

Financial Impact

These recommendations will have no financial impact on the City.

The Deputy City Manager and Chief Financial Officer has reviewed this report and agrees with the financial impact information.

Summary

This report recommends the adoption of a new City of Toronto Municipal Code, Chapter 19 ("Chapter 19") – "Business Improvement Areas" ("BIAs"), made necessary by the enactment of the City of Toronto Act, 2006 (the "Act").

The new Chapter 19 will provide within one document a clear set of guidelines governing the establishment of BIAs and BIA activities, and will help ensure improved BIA administration, financial management, and accountability.

The new Chapter 19 contains many of the BIA-related provisions of the Municipal Act, 2001, as well as new provisions related to financial management, the activities that BIAs are allowed to undertake, and clarifications and refinements with respect to procedures for establishing or amending the boundaries of a BIA.

It is intended that the new Code Chapter 19 shall apply to new BIAs to be created after the enactment of the Act, and to all existing BIAs previously established under the Municipal Act, 2001. To this end, it is recommended that Council dissolve all existing Boards of Management ("Boards") and re-establish them as City Boards.

This report also recommends that Council delegate to the community councils the authority to establish new BIA Boards in order to streamline the appointment procedure for BIA Board members.

3a New Municipal Code Chapter 19 - Business Improvement Areas

Recommendations

Summary

Attaching a report regarding strip plaza rehabilitation. The success of this plan will necessitate some amendments to Chapter 19 of the New City of Toronto Municipal Code which the Economic Development Committee presently has before it, and submitting the matter in an attempt to co-ordinate efforts with the work of the Economic Development Committee.

In order to accomplish a cleanup of suburban strip plazas it will, at some point in time, be necessary to consider establishing "Special Policy Areas" under this section. This will ultimately require four amendments to the Toronto Municipal Code.

Financial Impact

No City funding is required since Business Improvement Area budgets are raised by a special levy on members. Approval of the three recommended BIA budgets in this report will generate a total of \$433,979 for the respective BIAs.

All of the 2007 BIA operating budgets submitted for consideration are balanced budgets. The appeal provision surplus or appeal provision deficit for each individual BIA, as determined by the Revenue Services Division, has been addressed by each BIA and incorporated into their 2007 Operating Budget. The BIA budgets have provided for required capital cost-sharing contributions for those projects approved in 2006 or prior and carried forward into 2007, as well as new capital cost-share projects approved in the 2007 Capital Budget for Economic Development, Culture and Tourism.

Summary

This report brings forward Business Improvement Area (BIA) annual operating budgets for approval by Council as required by the City of Toronto Act, 2006. Council approval is required to permit the City to collect funds through the tax levy on behalf of the BIAs.

Complete budgets and supporting documentation received to-date have been reviewed and are reported herein; BIA budgets received after this date will be brought forward in later reports. Of the 61 established BIAs, a total of 55 BIA budgets have been approved by Council to-date; five BIA budgets are submitted for approval in this report; and one BIA has yet to submit its 2007 operating budget, as referred to in Appendix B.

The original Roncesvalles Village BIA 2007 operating budget that was adopted by Council on February 5 and 6, 2007 is being rescinded, to be replaced by the revised 2007 budget approved by the Board and general membership of the expanded Roncesvalles Village BIA recommended in this report.

Summary

This report recommends the renewal of a multi-year agreement with each of the four Torontobased arts and cultural organizations under the Arts and Culture - Local Arts Service Organizations (LASOs) category within the Community Partnership and Investment Program (CPIP).

Community arts is the bedrock of the City's cultural ecology. The LASOs are an essential component that helps build the City's cultural infrastructure through the programs and services they deliver. Through those programs and services the LASOs forge connections between artists in the community and bring together diverse groups which together build vital neighbourhoods that are the foundation of our Creative City. Since amalgamation, City Council has been providing financial support to enhance the LASOs' role in fostering community arts development. The City recognizes the importance of supporting arts and culture activities for Torontonians. These events enliven our shared expressions, enrich the quality of life and place for both residents and visitors, and encourage cultural tourism. The City continues its long history in supporting organizations and individual artists through funding allocations made through the Toronto Arts Council. The multi-year agreement between the TAC and the City serves the arts and culture community further. This agreement allows for a financial and administrative reporting practice, and provides the TAC the necessary commitment and resources to manage the granting practice effectively and efficiently exercise its responsibilities to the City.
