## **Manufacturing Matters to Toronto - Motion M157**

(October 24, 2007) Letter from City Council.

## Summary

City Council on October 22 and 23, 2007, referred the following Member Motion M157, headed "Manufacturing Matters to Toronto" by Councillor Augimeri, seconded by Councillor Rae, to the Economic Development Committee:

Canada's manufacturing sector is a critical part of the national economy: it is highly productive, generates the highest value-added in the economy compared to all other economic sectors, accounts for two-thirds of our nation's total exports and funds three-quarters of all private sector research.

Over the last five years, Canada has suffered a quarter million manufacturing job losses, across a diverse range of sectors including: auto assembly, auto parts, food and beverage, fish processing, shipbuilding, electronics, electrical, rubber, plastics, steel, wood, paper, metal and general manufacturing.

These job losses are the result of permanent and indefinite layoffs of workers, bankruptcies and plant closures, workplace downsizing, work relocation and production off-shoring to countries both within North America (United States and Mexico) and internationally.

The loss of manufacturing jobs has devastated workers, families and communities from coast to coast, and restricts the amount of quality job prospects for our children and grandchildren.

The loss of manufacturing jobs has placed an added financial strain on municipal governments to deliver increased demands for social services at the local level. At the same time, they are experiencing a shrinking tax base.

The lack of federal government attention to the critical issues of unfair trade and markets closed to Canadian goods, the persistently high Canadian dollar, the de-industrialization of Canada's economy and its associated impact, investment strategy, public procurement policies and inadequate protection for workers has resulted in a crisis for Canadian manufacturing workers.

#### Recommendations:

- 1. That Toronto City Council, on behalf of City residents, call on the Federal Government to take action in addressing the impact of manufacturing job loss in the Toronto region and in other communities across Canada by:
  - a. identifying the manufacturing industry as a strategic sector in Canada's economic development;
  - b. undertaking a comprehensive review of the causes and consequences of manufacturing job loss;
  - c. establishing a sectoral task force to review ways Canada can strengthen the manufacturing sector;
  - d. adopting a comprehensive and integrated set of economic, fiscal and monetary policies a framework for fair trade that will both strengthen domestic manufacturing and protect manufacturing jobs; and
  - e. ensuring that all Canadian workers are protected in job loss, through the improvement of bankruptcy laws, wage protection, pension protection, transition programs, improved training and relocation programs and enhanced Employment Insurance benefits.

## **Green Economic Sector Development Strategy Work Plan and Required Resources**

## **Culture Build Investment Program – 2007 Allocations**

(October 19, 2007) Report from Deputy City Manager Sue Corke.

#### Recommendations

The Deputy City Manager responsible for Economic Development, Culture and Tourism recommends that:

## **Financial Impact**

The 2007 Approved Budget for the 6<sup>th</sup> Annual Culture Build Investment Program within the Community Partnership and Investment Program is \$250,000.00 towards the state of good repair of existing non-City-owned, not-for-profit cultural facilities in Toronto. This report recommends an allocation of \$321,000.00 to seven organizations. One-time additional funding of \$71,000.00 is recommended from the Cultural Facilities Capital Grants Reserve Fund XR1211. The purpose of this reserve fund is to provide funds to assist the City's not-for-profit cultural sector with financing for state of good repair capital projects. The Reserve Fund balance was \$110,756.00 as of September 30, 2007.

The Deputy City Manager and Chief Financial Officer has reviewed this report and concurs with the financial impact.

## **Summary**

This is the sixth year of the Culture Build Investment Program. To date, the City has provided funding for 53 projects in order that not-for-profit cultural organizations can bring their facilities up to a state of good repair.

The recommendations for allocations contained in this report are the result of a review of the applications received at the September 14, 2007 deadline. The administration of the review was carried out in accordance with the City of Toronto Grants Policy as adopted by Council on December 16 and 17, 1998.

The arts and cultural organizations that are supported through the Culture Build Investment Program provide a wide variety of opportunities for residents of Toronto to participate in the arts as participants, volunteers or audience members. In the last six years, the Culture Build Investment Program has helped to further bring several of these organizations' facilities closer to a state of good repair.

## **Toronto Arts Council 2006 Annual Allocations Report**

## **Financial Impact**

No financial impact.

## Summary

This report provides information on the allocations made by the Toronto Arts Council (TAC) in 2006. The TAC's 2006 allocation from the City of Toronto's Community Partnership and Investment Program budget was \$10,152,560 that included \$9,213,270 for funding allocations and \$939,290 for operations.

A great city fosters a vibrant cultural scene and recognizes the importance of the arts to the quality of life of its citizens. Strategic municipal investment is a key factor in generating a healthy city economy, promoting cultural tourism, creating training and employment opportunities, and seeding the cultural industries. It is an important tool for strengthening neighbourhoods through increased youth engagement and community pride. The TAC offers funding programs to the City's arts organizations and professional artists. These programs, funded through the City of Toronto, invest in a broad range of activities from individual creation and small start-up projects to some of Canada's largest and most renowned arts institutions.

City Council continues its long history in supporting arts and culture organizations and individual artists through funding administered by the Toronto Arts Council. The Annual Allocations Report for the period January 1 to December 31, 2006, submitted by the TAC advised City Council on funding activities during this period and the support City Council has provided to Toronto's meritorious arts organizations, artists and creators.
