#### **DECISION HISTORY**

City Council, on April 12, 13 and 14, 2005, adopted, without amendment, Clause 7 of Report 3 of the Administration Committee from the Commissioner of Corporate Services entitled "Offers of Compensation - Expropriation of part of 1251 Tapscott Road - McNicoll Avenue Extension Project (Ward 42 - Scarborough-Rouge River)".

Funding for this project was then received by the City pursuant to the Core Servicing Agreement entered into by the City with the developers of the Morningside Heights Community.

#### **COMMENTS**

Facilities and Real Estate, in consultation with Legal Services, are ready to proceed with the offers of compensation to the owners of the subject lands resulting in developers' possession, right of access to the lands and disbursement of funds by November 2007. Council approval of a budget is required to facilitate these fully funded expenditures.
