1a Framework for a Climate Change and Clean Air Action Plan

(March 22, 2007) report from Deputy City Manager Richard Butts.

Recommendations

It is recommended that the Executive Committee request the Deputy City Manager to proceed with public engagement on the framework for a Climate Change and Clean Air Action Plan, and report back to Executive Committee in time for the July 2007 session of City Council.

Financial Impact

The recommended Action Plan will be developed using funds currently contained in the 2007 Toronto Environment Office operating budget, with re-allocation of funds, on an as required basis, from within other 2007 operating budgets. The Action Plan will identify program priorities for ABC&D's and new 2008 operating and capital budget pressures.

The Deputy City Manager and Chief Financial Officer has reviewed this report and agrees with the financial impact information.

Summary

The City of Toronto (the "City") is a committed participant in the growing global effort to address climate change and improve local air quality. This is reflected in the Mayor's call for the development of a comprehensive climate change plan to cut greenhouse gas emissions and the development of an aggressive clean air action plan.

New energy conservation and renewable energy technologies hold great promise for reducing emissions in the future. However, in the short-term we cannot allow greenhouse gas levels to increase and air quality to further deteriorate and we must take action now.

The City, as a government and an urban area, can and must continue to lead by example in efforts towards cleaner air and lower greenhouse gas emissions. By engaging every member of the community and all key sectors in partnership with the City, significant, lasting and positive change can occur. Through an emphasis on personal responsibility we trigger personal ability and desire to effect change.

In order to ensure that the maximum results possible are attained, a co-ordinated effort on the part of the City's agencies, boards, commissions and divisions ("ABC&D's"), and the urban community of Toronto, including residents and the business sector, will be required. A Climate Change and Clean Air Action Plan (the "Action Plan") that is innovative, reflects progressive ideas and is bold in its implementation will guide the City – both the City government and the Toronto urban area -- in meeting its objectives.

The working title for the Action Plan is "Change is in the Air". A draft framework for the Action Plan is enclosed with this report and will be used as the basis for engaging the citizens of Toronto in discussion and action. The framework provides examples of actions to address the major sources of greenhouse gases and smog-producing emissions in the Toronto urban area and beyond.

This report recommends that Executive Committee direct the Deputy City Manager to proceed with engagement of the public and stakeholders in a review of the framework for a Climate Change and Clean Air Action Plan, and report back to Executive Committee on the outcomes.

Toronto Energy Plan - Update and Related Initiatives

(March 7, 2007) report from the Chief Corporate Officer

Recommendations

The Chief Corporate Officer recommends that:

- 1. Toronto Water, the Toronto Transit Commission, the Toronto Community Housing Corporation, and other ABCDs as appropriate, work with Facilities and Real Estate to:
 - identify approved capital projects and projects proposed in their 2007 Capital Budgets and 2008-2011 Capital Plans with the potential for energy savings in order to determine their eligibility for funding under the 90 MW program;
 - identify and implement potential Demand Response opportunities in cooperation with Toronto Hydro Energy Services Inc. (THESI);
 - identify potential projects for funding under the OPA's upcoming Clean Energy Standard Offer Program;
- 2. the Chief Planner and Executive Director, City Planning, and the Chief Corporate Officer ensure that applicants for developments over 1,000 square metres of gross floor area are advised of the opportunity to enrol in the Better Buildings New Construction Program, and the Chief Planner note in any report prepared for Council whether the applicant has enrolled in the Program, and the level of energy efficiency that is contemplated for the development; and

3. the Chief Corporate Officer communicate to Natural Resources Canada the City's interest in working with them on the EcoEnergy Efficiency Initiative.

Financial Impact

The final Energy Plan recommendations, when reported to Council later this year, will have impact on both the capital and operating budgets. Potential financial implications will be reported at that time.

Once the City negotiates an agreement for the 90 MW program, the OPA will provide funding for eligible projects until December 31, 2010. The amount of funding will depend on the details of the contract with the OPA, and will be based on the electricity savings generated. Payments from the OPA may take the form of up-front capital funding, payments for availability of load dispatch, and/or payments for demonstrated kilowatts/kilowatt hours saved. The OPA will also provide funds to cover the City's overhead program costs. Further report on this issue will be provided as part of the final Energy Plan.

The Deputy City Manager and Chief Financial Officer has reviewed this report and agrees with the financial impact information.

Summary

This report provides an update on the preparation of the Toronto Energy Plan, including the development of a program to achieve 90 megawatts (MW) of electricity savings across the city by 2010. Under this program, the Ontario Power Authority (OPA) will provide incentive payments to eligible City and community projects. The report also identifies three other issues:

- the proposed linking of Police Headquarters and City Hall to Enwave's Deep Lake Water Cooling system;
- the proposed construction of a 3rd major electricity transmission line into the downtown; and
- opportunities for cooperation with the federal government on energy efficiency.

In the short term, the recommendations in this report will help the City achieve its target of reducing energy consumption by 15% within its own operations, as well as reducing electricity consumption in the wider community. The recommendations will also assist in developing a longer-term plan for moving Toronto from its current unsustainable state of energy consumption to a state of energy sustainability, through energy conservation and the generation of clean and renewable energy.

Committee Recommendations

The Executive Committee recommended to City Council that:

1. Toronto Water, the Toronto Transit Commission, the Toronto Community Housing Corporation, and other ABCDs as appropriate, work with Facilities and Real Estate to:

- i. identify approved capital projects and projects proposed in their 2007 Capital Budgets and 2008-2011 Capital Plans with the potential for energy savings in order to determine their eligibility for funding under the 90 MW program;
- ii. identify and implement potential Demand Response opportunities in cooperation with Toronto Hydro Energy Services Inc. (THESI);
- iii. identify potential projects for funding under the OPA's upcoming Clean Energy Standard Offer Program;
- 2. the Chief Planner and Executive Director, City Planning, and the Chief Corporate Officer ensure that applicants for developments over 1,000 square metres of gross floor area are advised of the opportunity to enroll in the Better Buildings New Construction Program, and the Chief Planner note in any report prepared for Council whether the applicant has enrolled in the Program, and the level of energy efficiency that is contemplated for the development;
- 3. the Chief Corporate Officer communicate to Natural Resources Canada the City's interest in working with them on the EcoEnergy Efficiency Initiative;
- 4. that the Chief Corporate Officer be requested to also work with the Municipal, University, School and Hospital sector to identify and support energy saving opportunities; (Motions by Councillor Mihevc)
- 5. the City co-ordinate with Toronto Hydro for a combined 180 megawatts in conservation from the Ontario Power Authority; and
- 6. that the Chief Corporate Officer be requested to submit a report to the Executive Committee, as soon as possible, on the third line and whether the electricity requirements could be met through conservation and demand reduction. (**Motions by Councillor Fletcher**)

Toronto Environmental Protection Plan (TEPP): Toward Integrated Action on Climate Change and Air-Quality

(March 9, 2007) Member Motion from Councillor Walker, seconded by Councillor Thompson

Recommendations

- 1. Council adopt a carbon dioxide and greenhouse gas emissions reduction goal of 20% relative to 1990 levels by the year 2012 as a City-wide target for the City of Toronto;
- 2. Council urge the Federal government to expeditiously implement measures to reduce Canada's pollution emissions to meet our commitments to the Kyoto Protocol;
- 3. Council direct the City Manager to identify all areas (i.e., by-law amendments and purchasing parameters) of City business that could be changed in order to help the City of Toronto to achieve its pollution emission reduction program, reporting no later than to the July meeting of the Executive Committee;
- 4. Council direct the City Manager to produce a Status Report to the Executive Committee on all City "green" initiatives (ongoing and completed since Amalgamation) to support the City's "Clean, Green and Healthy: A Plan for an Environmentally Sustainable Toronto (February 2000)", and to produce updated Appendices A and B adopted with that Plan;

Council authorize the Mayor, on behalf of City Council, to develop a Resolution on climate change action to be supported by other Mayors in Canada (similar to the U.S. Conference of Mayors, January 25, 2007) with the aim of receiving specific funding (Block Grants proportionate to population) from the Federal government for environmental initiatives to reduce pollution emissions and aid Canadian Cities' transition to sustainability;
- 7. Council direct the City Manager to report to the Executive Committee on the powers of the new City of Toronto Act and the new opportunities for the City to use to reach the goals of our climate action plan (i.e. providing incentives for retrofit modifications or renewable energy production by individuals, homeowners, and owners of multi-residential dwellings);
- 8. Council urge the Provincial government to assist the City of Toronto to meet its environmental protection goals by providing programs and sustained funding (i.e., for annual transit system construction);
- 9. Council urge the Federal government to direct the Canadian International Development Agency (CIDA) to conduct projects in developing countries using the Kyoto Protocol's clean development mechanism (CDM) to help Canada meet its Kyoto Protocol emission reduction target by 2012;
- 10. Council direct the City Manager to report to the Executive Committee on the Resolutions passed by the U.S. Conference of Mayors for action against global warming, including the U.S. Mayors Climate Protection Agreement and the \$4 Billion Energy and Environment Block Grant proposal;

- 11. Council adopt a policy of annually reporting pollution emissions to the public, such report to be completed by the Auditor General;
- 12. Council urge the Provincial government to permanently close the remaining four (4) coal-fired power plants in Ontario (Nanticoke, near Lake Erie; Lambton, near Sarnia; Atikokan and Thunder Bay, both in the northwest) as soon as possible; and
- 13. Council urge the Federal government to work with Canadian cities, especially Toronto as its largest, to help the country achieve and surpass its Kyoto Protocol commitments.

Establish and Construct The Toronto Environmental Protection Centre (TEP) in the Eastern Portlands

(March 9, 2007) Member Motion from Councillor Walker, seconded by Councillor Thompson

Recommendations

- 1. Council instruct the City Manager and appropriate staff to investigate establishing a "Toronto Environmental Protection Centre" to implement the goals of the City of Toronto Environmental Plan, and findings of this investigation be reported to the June 2007 meeting of the Executive Committee; and
- 2. Summary

City Council on March 5 to 8, 2007, referred the Motion by Councillor Walker, seconded by Councillor Thompson, to the Executive Committee.

To help the Federal government reach Canada's commitment to the Kyoto Protocol, Toronto needs to create resources for its citizens and businesses. One such centralized resource should be an Environmental Protection Centre where information could be disseminated, seminars could be held, questions could be asked and sustainable technologies could be purchased, spawned and nurtured.

For instance, to show Chicago's (Illinois, USA) commitment to reaching its environmental protection targets, especially a reduction in pollution emissions, Chicago's Mayor has established and constructed the Chicago Center for Green Technology. Chicago's centre is constructed using the LEED (Leader in Energy Efficiency in Design) Platinum standard and houses a small factory to produce solar panels on site.

Toronto should take its lead from Chicago and build a centre for excellence in environmental protection to lead Canada to reach our common reduction targets under the Kyoto Protocol.

Toronto Community Housing Corporation 2007 – 2009 Community Management Plan

(March 9, 2007) report from the City Manager

Recommendations

The City Manager recommends that:

- 1. City Council, in its role as Shareholder of the Toronto Community Housing Corporation, receive Toronto Community Housing Corporation's 2007 2009 Community Management Plan; and
- 2. the City Manager forward a copy of this report to the Board of Directors of the Toronto Community Housing Corporation as the City's comments.

Financial Impact

The recommendations in this report have no financial impact.

Through the submission of its 2007 – 2009 CMP, TCHC has requested a \$7 million increase to its annual operating subsidy. The City's operating agreement with TCHC does not include a mechanism to increase annual funding for the specific items identified in the 2007 – 2009 CMP. If the agreement were to be amended to allow for these items, the Shelter, Support and Housing Administration (SSHA) operating budget would have to increase by \$7 million annually to accommodate TCHC's request. This request from TCHC will be reviewed and reported on as part of the 2007 operating budget process.

Summary

The City's Shareholder Direction to Toronto Community Housing Corporation (TCHC) requires TCHC to submit an annual Community Management Plan (CMP) to the City for comment. The CMP is a rolling three-year business plan including long-term business strategies, key multi-year targets and financial plans, but is not a detailed activity plan. The

City's comments on the CMP are to be taken into consideration in preparing detailed action plans to be approved by TCHC's Board of Directors.

A review by staff indicates that the 2007 – 2009 CMP complies with the requirements of the Shareholder Direction. The CMP is an ambitious plan that proposes to improve housing for TCHC tenants and the services and activities TCHC undertakes. Through implementing the Plan, TCHC will help deliver on the Mayor's commitment to provide 1,000 new affordable housing units, especially through the revitalization of Regent Park. The CMP highlights the need for the City and TCHC to co-ordinate their capital programs on projects of mutual interest such as Regent Park, Lawrence Heights and the Railway lands. As part of its CMP, TCHC has requested a \$7 million annual increase to its funding. This request will be reviewed and reported on as part of the 2007 operating budget process.

Decision Advice and Other Information

Recruitment and Selection Process for Citizen Members of the Toronto Zoo Board of Management

(March 12, 2007) report from the City Manager

Recommendations

The City Manager recommends that:

- 1. City Council amend the City's Public Appointments Policy by replacing Appendix D.12 with the revised Appendix D.12 attached to this report that sets out the eligibility requirements, necessary qualifications, and recruitment and selection process for citizen members on the Toronto Zoo Board of Management; and

Financial Impact Statement

Costs related to advertising for the recruitment of the Zoo Board citizen members from the Toronto community at large is approximately \$5000. Funds are available in the 2007 base budget for this type of recruitment activity pending approval of the 2007 operating budget. No additional funds are required.

The Chief Financial Officer and Deputy City Manager has reviewed this report and concurs with the financial impact statement.

Summary

At its February 2007 meeting, City Council approved a change of the Board of Management of the Toronto Zoo and requested the City Manager develop the eligibility, qualifications, and recruitment and selection process in consultation with the Chief Executive Officer of the Toronto Zoo.

The previous Zoo Board composition included six members of Council, three members nominated by the Toronto Zoo Foundation Board and two scientific citizen members. The amended Zoo Board composition includes six members of Council, one member nominated by the Toronto Zoo Foundation Board and four citizen members. The total composition remains at eleven members.

The Toronto Zoo has proposed that all four citizen members be recruited by the Board of Management using the "by invitation process" to ensure the citizen members have specific skills and experience to support the Zoo in its future work and planned initiatives. The Zoo has also proposed that the residency requirement for citizen members be waived.

The City Manager is recommending that two citizen members be selected by invitation as is currently the case and two citizens be recruited through an open advertised process. Using a combination of processes will enable recruitment of individuals with specific skills, qualifications and experience while at the same time ensuring representation on the board from the broader Toronto community.

Appendix D.12 attached to this report outlines the eligibility requirements and sets out the recruitment and selection process.

Financial Impact:

As shown in Table 1 below, Tax Supported Programs spent \$1.069 billion or 69.8 percent of the 2006 approved cash flow of \$1.531 billion during the year ended December 31, 2006. By comparison, spending in 2004 approximated 68.3 percent and in 2005, 68.3 percent of the respective Council approved cash flow. Excluding uncontrollable projects (defined as projects that are subject to conditions that are not within the control of staff. such as unforeseen natural or environmental factors, and dependency on third party performance), the 2006 Tax Supported Programs' spent 72.4 percent of the adjusted cash flow:

Rate-Supported Programs spent \$272.810 million or 62.8 percent of the 2006 approved cash flow of \$434.177 million. Excluding uncontrollable projects, the spending rate improves to 70.2 percent.

In accordance with the City's Carry Forward Policy, the 2007 Budget Committee Recommended Capital Budget will include 2006 unspent funding carried forward to 2007. This will enable staff to complete projects for which capital work was not completed in 2006 as planned. It should be noted that the majority of the reduced spending on capital projects in the fourth quarter are committed and should be spent in early 2007.

It is noted that in compliance with good financial management practices, debt is issued only when needed to finance actual or committed capital expenditures. This strategy minimizes the incurrence of debt service cost and the resultant impact on the Operating Budget. In accordance with the Financial Control By-law, completed projects will be closed and any unspent funds will be returned to the original funding source. A recommended list of project closures will be included in the final 2006 Year-end Capital Variance report.

Summary

The purpose of this report is to provide the City of Toronto Preliminary Capital Variance Report for the year ended December 31, 2006, and to request Council's approval of technical budget adjustments which reallocate funds between projects with no incremental impact on the Council Approved 2006 Capital Budget. A final report will be submitted to Council following the completion of the external audit of the City's accounts and financial statements.

Capital spending during 2006 totalled \$1.342 billion or 68.3% of the approved cash flow of \$1.965 billion. The under expenditure is primarily attributed to the inability to find or secure suitable sites in accordance with planned timeframes; delays in securing funds from cost-sharing partners; and, significantly higher than expected rainfall which delayed performance of roofing and asphalt projects, exterior site work, park construction projects and playground replacement work. In addition, several projects were completed under-budget. Unspent funds for incomplete projects will be carried forward to 2007 on an as required basis, in accordance with the City's Carry Forward Policy

City Council at its meeting of September 28, 29, 30 and October 1, 2004, adopted as amended, by a vote of 35 to 8, the Toronto Election Finance Review Task Force recommendations package for reform of municipal election campaign finances in the City of Toronto. This package was then forwarded to our Provincial Minister of Municipal Affairs and Housing, the Honourable John Gerretsen, on October 6, 2004.

These reforms were adopted by City Council to improve electoral fiscal transparency and accountability, to reduce the influence of special interests and to eliminate the financial advantages of incumbency.

On October 31, 2005, by a vote of 29 to 3, City Council re-affirmed its support for these reforms by adopting a motion regarding the urgent implementation of the Toronto Election Finance Review Task Force recommendations.

The main recommendations of this reform package are:

- 1. Prohibit all corporate and union donations to municipal election campaigns
- 2. Disallow candidates from transferring financial surpluses from one campaign to the next.
- 3. Update spending limits and redefine rules with respect to excluded expenses.

4. Require Elections Ontario to be responsible for the monitoring and enforcement of the provisions of the Municipal Elections Act, 1996.

As we all know, Minister Gerretsen did not include the permissive legislation City Council needed to implement any of the Toronto Election Finance Review Task Force recommendations until Bill 53, Stronger City of Toronto for a Stronger Ontario Act, 2006, which was introduced in the Legislature for First Reading on December 14, 2005 and given Royal Assent on June 12, 2006. Further, the provincial government did not include in Bill 53 the required permissions to implement all the recommendations of the Toronto Election Finance Review Task Force adopted by City Council, except to prohibit corporate and union donations to municipal election campaigns.

For nearly a year and a half, the provincial government held off on passing the needed reforms for the City of Toronto. This prevented City Council from implementing new election campaign finance rules for the 2006 Municipal Election.

Now there is no reason to delay. City Council needs to implement new rules governing municipal election campaign finances as per the Toronto Election Finance Review Task Force recommendations.

Habitat for Humanity Request for Fee Forgiveness - 4200 Kingston Road

(February 15, 2007) Member Motion from Councillor Ainslie, seconded by Councillor De Baeremaeker

Recommendations

1. City Council agree to rebate and waive all fees attributed to the development and construction by Habitat for Humanity Toronto of nineteen town homes at 4200 Kingston Road in Scarborough.

Summary

City Council on February 5 to 8, 2007, referred the Motion by Councillor Ainslie, seconded by Councillor De Baeremaeker, to the Executive Committee stating that Habitat for Humanity Toronto is a non-profit charitable organization which has had many successful years of experience in the development and construction of affordable ownership housing for low income families with children. The average sale price of a home in Toronto in 2005 was \$330,000.00 and the average rent of an apartment with three or more bedrooms in 2005 was \$1,200.00, meaning that families with lower incomes are having a very difficult time in finding suitable housing which they could afford. Habitat for Humanity Toronto constructs and renovates homes which are then sold to families at reduced rates with zero-interest mortgages.

Habitat for Humanity Toronto has previously requested and been granted dispensation from the payment of fees related to the construction of homes consistent with the Council policy supporting the construction of affordable rental housing stock by other non-profit organizations, in order to further reduce the housing costs for projects at 38 St.Lawrence Street, 150 Pinery Trail in Scarborough and 8 Elsinore Path in Etobicoke.

Discussions with staff have been conducted: City right-of-way advised that there may be hoarding fees if Habitat chooses to construct a fence on the City right-of-way to protect the public from their construction site. These fees are estimated at \$535.00 plus a monthly fee of \$240.00 for the time that the hoarding is in place. Other applicable fees would be Toronto Water administrative fee, which is usually a percentage of the servicing cost within the road allowance.

Council Support for Post-Secondary Students

(February 8, 2007) Member Motion from Councillor Perruzza, seconded by Councillor Vaughan

Recommendations

- 1. In recognizing education as a basic right of all people and a necessity of the knowledge-based economy, that City Council endorse Ontario Legislative Assembly Bill 12 which, if passed, will keep tuition fees at their current levels until the completion of the fall provincial elections.
- 2. That City Council petition the Government of Ontario to adopt and implement Bill 12.
- 3. That members of Council be encouraged to support the National Student Day of Action on February 7, 2007.

Summary

According to Assoc. of Colleges of Applied Arts & Technology of Ontario, more than 70% of new job openings in Canada will require postsecondary education. Despite this, only half of high school students in Ontario go directly to college or university. The vast majority of students who do not attend a post-secondary institution cite the cost of education as the main reason.

This reality is the result of sky-rocketing tuition fees & the debt burden that accompanies them. Tuition fees in Ont have increased by more than 4 times the rate of inflation in the past 15 yrs and are now the 3rd highest in Canada.

To address the problem of high tuition fees, which is acknowledged as a barrier to accessibility, the current Ontario Liberal government ran on a platform of increasing funding to post-secondary education institutions & immediately freezing tuition fees.

The provincial government cancelled the tuition fee freeze & approved a fee increase of 5% to 8% in the year 2006 as part of a 4 yr plan which is likely to increases of 20% to 36% in just 4 years.

The Government of Ontario increased student loan limits which will increase average student loan debt for a 4 yr post-secondary programme to approximately \$28,000. Considering the average student debt in Ontario is already the highest in Canada (in excess of \$25,000 after graduation), further fee increases resulting in mounting debt will exacerbate the lack of accessibility to post-secondary education for low and middle-income families.

The Department of Epidemiology at the University of Western Ontario proved that accessibility has been affected by tuition fee increases when it completed a 4 yr survey entitled Study on Accessibility. The study examined participation rates by socio-economic status & documented a 50% decline in the participation rates of low income students. This occurred at the same time as the deregulation of tuition fees for graduate & professional programmes pushed fees up considerably.

A number of organizations including the Canadian Federation of Students, Ontario Confederation of University Faculty Assoc., and the Canadian Union of Public Employees have been calling for the government to continue the tuition fee freeze. This sentiment is reciprocated by the population at large, as 70% of Ontarians support freezing tuition fees and 89% consider post-secondary education a high priority for the government of Ontario according to survey's commissioned by the OCUFA.

Rosario Marchese, MPP for Trinity-Spadina, has presented Bill 12 No Tuition Hikes Act, 2005 to the Legislative Assembly of Ontario. The bill calls for no tuition fee increases until voters have had a chance to decide on the matter in the upcoming Ontario election in October 2007 and has passed 1st reading.

With over 169 589 post-secondary students currently studying in the GTA, the impact of this fee increase on Toronto families is far reaching.

Mayor of Toronto, David Miller was elected with a strong mandate from the people of Toronto who want government to provide opportunities for them to improve their quality of life that allow them to better contribute to Toronto communities & the success of the City. Part of this mandate is to lobby the government for accessible post-secondary education, which Mayor Miller summarized by stating:

"I pledge to represent the tens of thousands of students that are enrolled in Toronto's postsecondary institutions by demanding that the Premier of Ontario, Minister of Education, Minister of Training, Colleges & Universities, and the Federal Government of Canada freeze tuition fees and develop a long-term strategy to reduce tuition fees."

Toronto City Council should join the other 10 Municipalities, including Halifax, NS, Kamloops, BC, and Sudbury, On, that are urging their respective provincial governments to make post-secondary education affordable.

Prohibiting Lobbyists from Contributing to Municipal Election Campaigns
