Islington Avenue/Dundas Street West Community -Speed Limit Reduction

SUMMARY

The purpose of this report is to obtain approval to reduce the legal speed limit on the majority of roads within the community bounded by Dundas Street West, Islington Avenue, Wimbleton Road, and Hilldowntree Road from 50 km/h to 40 km/h.

As the 40 km/h Speed Limit Warrant requirements are achieved in this community, 40 km/h speed limits are recommended on all of the streets bounded by Dundas Street West, Islington Avenue, Wimbleton Road and Hilldowntree Road (Chestnut Hills Parkway, Finchley Road, Herne Hill, Robin Hood Road and Nottingham Drive) with the exception of Chestnut Hills Crescent.

RECOMMENDATIONS

Transportation Services recommends that Council approve the following:

1. The speed limit on Chestnut Hills Parkway, Finchley Road, Herne Hill, Robin Hood Road and Nottingham Drive be reduced from 50 km/h to 40 km/h as the requirements of the 40 km/h Speed Limit Warrant are achieved; including the enacting of any appropriate bills.

DECISION HISTORY

Speed studies were conducted applying the 40 km/h Speed Limit Warrant on Chestnut Hills Parkway, Finchley Road, Herne Hill, Robin Hood Road and Nottingham Drive, as a result of a request from Councillor Gloria Lindsay Luby, Ward 4, Etobicoke Centre. The specific request was to examine the appropriate speed limits on the streets in this community. A map of the area is Attachment No. 1.

COMMENTS

1.

(i)

The area investigated is the residential community bounded by Dundas Street West, Islington Avenue, Wimbleton Road and Hilldowntree Road. The speed limit on the streets in this community is currently 50 km/h.

Within the subject area, all the streets, with the exception of Chestnut Hills Crescent have a pavement width of less than the 10.5 metres set out in the 40 km/h Speed Limit Warrant. In addition, Chestnut Hills Parkway, Finchley Road, Herne Hill, Robin Hood Road and Nottingham Drive do not have sidewalks on either side of the road.

The complete 40 km/h speed limit warrant is as follows:

The justification for the introduction of a 40 km/h speed limit is based on the following technical warrant. A 40 km/h speed limit may be implemented where the Road Width (A) criteria and either the Pedestrian Environment (B) or the Road and Traffic Environment (C) criteria is met.

As part of our review, we conducted speed studies on Chestnut Hills Parkway, Finchley Road, Herne Hill, Robin Hood Road and Nottingham Drive. Our study results are as follows:

* The 85th percentile is the speed at or below which the majority of motorists feel comfortable travelling under the existing roadway conditions
