Sign Variance Report 250 The East Mall – Dominion Store

SUMMARY

Toronto Building received a request from Javeid Akhtar, Signlogix Ltd., on behalf of BCIMC Realty Corporation for approval of variance from Chapter 215, Signs, of the former City of Etobicoke Municipal Code, to install a First Party Illuminated Fascia sign on the ground floor East elevation at 250 The East Mall, for the Dominion Supermarket store.

RECOMMENDATIONS

Toronto Building recommends that:

- 1. the request for variances be approved for the reasons outlined in this report; and
- 2. the applicant be advised, upon approval of variances, of the requirement to obtain the necessary sign permits.

FINANCIAL IMPACT

There are no financial implications resulting from the adoption of this report.

COMMENTS

The applicant is requesting an illuminated fascia sign for the Dominion Supermarket located in Cloverdale Mall. The store is situated at the south west corner of the single storey mall, and had recent renovations to the interior and exterior of the building.

Recently, Toronto Building had received sign permit applications for three Fascia Signs at 250 The East Mall. Permits were issued for two of the signs that are facing the streets. Namely, one sign is facing Dundas Street West and the other facing Highway 427. The proposed third sign facing the parking lot, on the east wall of the mall is not in compliance with the Sign Code.

A recent inspection of the site confirmed that the third sign has already been installed.

The sign does not comply with Chapter 215, Signs of the former City of Etobicoke Municipal Code in the following ways:

The applicant is requesting an Illuminated Business Identification Fascia Sign with a display area of 8.2 metres square. The Sign Code requires that this type of sign face a street however, the sign is facing a parking lot and is located on the east wall of the mall, and is not adjacent to any other buildings. This request is considered minor in nature and variance is recommended for approval.






