# NOTICE OF PUBLIC MEETING

#### **PROPOSAL**

To amend the former City of York By-law No. 1-83, as amended, with respect to the lands in the Haney Avenue/Foxwell Street and Duern Street/Handel Street Area, as shown on the attached map included on this notice.

The proposed amendment rezones the properties included within this area from an R2 – Residential Density Zone, to an R1 – Residential Density Area with an area specific zoning. The proposed area specific zoning will only permit single detached dwelling uses with regulations for lot frontage, floor space index, height, front yard landscaping, and parking. The proposed amendment regulation also contains provisions to permit the continued use and redevelopment of certain properties that are not single detached dwellings that would otherwise not be a permitted use in the proposed R1 Zoning District.
