

SUMMARY

This report is to advise on the status of the applications for 6 Lloyd Avenue. At the September 13, 2006 meeting of the Etobicoke York Community Council, Community Planning was requested to forward copies of all relevant reports and/or documents referenced in the Refusal Report related to the applications for 6 Lloyd Avenue. The reports have been forwarded to Clerks for copy and distribution to Community Council.

Since the September 13, 2006 meeting the Official Plan Amendment and Rezoning application for 6 Lloyd Avenue has been appealed by the owner to the Ontario Municipal Board, pursuant to Section 22 (7)(c) of the *Planning Act*, on the basis that the City failed to adopt the requested amendment. As of the submission of this report, no hearing date had been set. It is recommended that Council adopt the recommendations contained in the August 28, 2006 Refusal Report.



RECOMMENDATIONS

The City Planning Division recommends that:

1. City Council adopt the recommendations included in the August 28, 2006 Refusal Report on the Official Plan Amendment, Rezoning and Site Plan Approval Applications for 6 Lloyd Avenue.

FINANCIAL IMPACT

There are no financial implications.

DECISION HISTORY

The Etobicoke York Community Council considered a Refusal Report on the Official Plan Amendment, Rezoning and Site Plan Approval Applications for 6 Lloyd Avenue at its September 13, 2006 meeting. This matter was deferred to a Special Meeting of Community Council which was to be held on September 19, 2006. This meeting was cancelled and the matter has been advanced to the Etobicoke York Community Council meeting of January 2007.
