## **Mandatory Health Programs and Services Review**

(February 12, 2007) report from Medical Officer of Health

## **Summary**

Boards of Health throughout Ontario ensure the delivery of services as required by the

Mandatory Health Programs and Services Guidelines (MHPSG) of the Health Protection and Promotion Act. The Ontario government's Operation Health Protection (2004) outlines a three-year action plan to revitalize the public health system. This includes a review and revision of the MHPSG.

The Ministry of Health and Long Term Care, in partnership with the Ministry of Health Promotion and the Ministry of Child and Youth Services, is currently in the process of reviewing and revising the Standards which make up the MHPSG. A Technical Review Committee of Ministry staff and community stakeholders has been established to oversee the process and each Standard has been reviewed and revised through a series of stakeholder consultations and expert writing panels. The first draft of the new Ontario Public Health Standards will be released on February 19, 2007 for review and feedback. Each Board of Health and Health Unit has been invited to submit comments on the draft through an e-survey tool by Friday, March 9, 2007.

Toronto Public Health staff has established an internal process to co-ordinate the review and consolidate the feedback. The Board of Health has established a MHPSG Sub-committee to provide Board of Health input into the Toronto's response.

## Interim Evaluation Report on Toronto's Pesticide By-law

(February 9, 2007) report from Medical Officer of Health

## Summary

This report presents a preliminary evaluation of Toronto's Pesticide Bylaw (Municipal Code 612), which came into effect on April 1, 2004. The bylaw is being phased in together with an education program to promote natural lawn and garden care. Bylaw violation penalties began to apply for commercial pesticide users such as lawn care companies on September 1, 2005. Homeowners and renters will become subject to penalties for bylaw violations on September 1, 2007.

To evaluate the bylaw's impact, Toronto Public Health (TPH) has drawn on the best available data, primarily collected between 2003 and 2005. Early evidence shows promising signs of behaviour change regarding the use of pesticides in Toronto.

In 2005, 35 per cent fewer Toronto households reported any use of pesticides on their lawns, as compared with 2003. Furthermore, an increasing number of households report that they or their lawn care companies are using lower-risk pesticides and/or more natural alternatives. Each year, a consistent proportion of residents continue to hire lawn care or landscaping companies to care for their properties, and there is some evidence that Toronto's lawn care sector has grown each year since 2001. A majority of Torontonians, particularly those with lawns or gardens, know about the Pesticide Bylaw, and compliance is high.

It is essential that education, enforcement and evaluation activities continue in the years ahead to fully implement the bylaw and assess its impacts. This report identifies several TPH program priorities for 2007.

# **Eating Well with Canada's Food Guide - Assessment and Service Implications**

(February 12, 2007) report from Medical Officer of Health

## **Summary**

On February 5, 2007, Health Canada released Eating Well with Canada's Food Guide (see Attachment 1), an updated version of the 1992 Canada's Food Guide to Healthy Eating. The purpose of this report is to update the Board of Health on Eating Well with Canada's Food Guide, and to outline the steps that Toronto Public Health (TPH) will take to update resources, programs and services to incorporate the new Food Guide.

Eating Well with Canada's Food Guide is an improvement over the previous version because it provides clearer advice on the types and amounts of food to consume and is better tailored to meet the needs of Toronto's diverse ethno-cultural population.

As a result of the release of Eating Well with Canada's Food Guide, Toronto Public Health will review resources and program materials containing nutrition information to assess the need for revision. Those resources identified as a high priority will be revised in the very near future. In addition, there will be a need for staff training and for training and consultation with external partners. The implementation of Eating Well with Canada's Food Guide will be an important focus in Toronto Public Health nutrition programs and services over the next year.

## Establishment of a Dental Clinic at North York Civic Centre

(February 9, 2007) report from Medical Officer of Health

## Recommendations

The Medical Officer of Health recommends that:

- 1. City Council approve an additional \$480 thousand in the 2007 Toronto Public Health Capital Budget to establish a dental clinic at the North York Civic Centre;
- 2. the additional funds of \$480 thousand be repaid in the year 2008 (\$240 thousand) and 2009 (\$240 thousand) as summarized in Table 1; and
- 3. this report be forwarded to the Budget Committee.

## **Financial Impact**

The Request for Quotation (RFQ) to establish a dental clinic in the NYCC confirms previous findings of an earlier RFQ that the \$300,000 in the 2006 TPH Capital Budget is insufficient to renovate the space allocated for the dental clinic at the NYCC. The lowest qualifying bid from the current RFQ is \$621,239. The bids submitted range from \$614,500 to \$891,000. The total required renovation costs, including design, construction and project management fees, will be \$780,000. Therefore, an additional \$480,000 will be required in the TPH Capital Budget to complete this project. If the requested additional funds are approved, the repayment of the project cost would be extended to 2009. Repayment of the loan will be made using the savings realized from restructuring the delivery of services in the North York dental treatment program.

The Deputy City Manager and Chief Financial Officer has reviewed this report and agrees with the financial impact information.

## **Summary**

At its September 14, 2006 meeting, the Board of Health requested the Medical Officer of Health (MOH) to report back on alternative solutions to establishing a dental clinic at the North York Civic Centre (NYCC).

After examining the issues and the possible alternatives to locating the dental clinic elsewhere, the NYCC is recommended as the best option. The site is accessible by public transit, is known to the community and will be less costly in the long term. This report recommends that additional funds totalling \$480,000 be included in the 2007 TPH Capital Budget to complete the construction of the dental clinic at the North York Civic Centre. The amount required is larger than previously anticipated and is based on the results of the Request for Quotations (RFQ) process. It is also recommended that the repayment of the project cost be extended to 2009.

## Citizen Appointments to the Board of Health and Local Health Committees

## Summary

Given the significant role that the City's agencies, boards and commissions have in municipal governance and city services, it is important that the membership of these ABCs reflect the population of the city. It is estimated that by 2017, 50.6% of GTA residents will be members of racialized groups. Removing barriers to full participation of all communities and increasing the diversity of ABCs is necessary for ABCs to reflect the population.

Over the past several years, the City of Toronto has made a number of commitments to achieving greater diversity in its public appointments to ABCs, culminating in the approval and implementation of a Public Appointment Policy that specifically includes diversity.

The Board of Health has an opportunity to demonstrate commitment to diversity through appointments of citizen members to both the Board itself and its four Local Health Committees (LHC). The City of Toronto already has a policy and the Board has terms of reference that address diversity. Therefore, this can be achieved without the development of a separate and

distinct policy. Because of the limited number of citizen positions and the broad range of geographic, gender, ethnoracial, disability, and sexual orientation diversity that needs to be reflected in Board of Health and LHC membership, it is not recommended that specific targets be set. Rather, the Board of Health Nominating Sub-committee should increase diversity through active outreach, recruitment, screening and selection of its citizen appointments.
