# **Multi-residential Apartment Building Licensing Initiative**

(January 19, 2007) Member Motion from Councillor Anthony Perruzza, York West, Ward 8

## **Summary**

In 2004, the City of Toronto, in principle, adopted a framework strategy to allow for a licensing regime and enforcement protocol of privately-owned, multi-unit residential properties. This would allow for the funding of proactive inspections that would be an improvement over the current complaint-driven model, and ensure that such properties would meet the provisions of the Toronto Municipal Code. At the time of the report, provincial regulation prohibited the inception of a licensing system. With the passage of Bill 53, the City of Toronto Council now has the power to enact such a system.

#### **Decision Advice and Other Information**

The Licensing and Standards Committee:

- 1. consented to adding to the agenda for this meeting a Notice of Motion by Councillor Perruzza;
- 2. requested the Executive Director, Municipal Licensing and Standards to:
  - a. report to the Licensing and Standards Committee by June 2007 detailing options to license landlords and/or rental properties;
  - b. provide a briefing to the March 30, 2007 Licensing and Standards Committee on the status of the process, and
  - c. receive the package of information from the Association of Community Organizations for Reform Now for consideration in the options on licensing landlords and/or rental properties; and
