PURPOSE OF THE APPLICATION:

This is an application under Section 45 of the Planning Act, for variance from the provisions of the North York Zoning By-law 7625, as amended, to permit the existing dwelling to maintained as constructed on a lot reduced by severance.

REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

- 1. Proposed lot area of 675.8m²
 WHEREAS a minimum lot area of 690m² is required; and
- 2. Proposed rear yard setback of 8.75m to the existing dwelling WHEREAS a minimum setback of 9.5m is required.
