# Stopping Prohibitions: Bayview Ridge

## SUMMARY

This staff report is about a matter that the Community Council has delegated authority to make a final decision (provided that it is not amended so that it varies with City policy or by-laws).

To obtain approval to prohibit stopping from 8:00 a.m. to 6:00 p.m., Monday to Friday, on both sides of Bayview Ridge, west of Bayview Avenue.

The installation of stopping prohibitions will address concerns related to parking activities on Bayview Ridge, west of Bayview Avenue.

## RECOMMENDATIONS

Transportation Services, North York District recommends that:

- 1. Schedule IX of By-law No. 31001, of the former City of North York, be amended to prohibit stopping on both sides of Bayview Ridge from 8:00 a.m. to 6:00 p.m., Monday to Friday, from the westerly limit of Bayview Avenue to a point 118 metres west thereof; and
- 2. the appropriate City Officials be authorized and directed to take whatever action deemed necessary to implement the foregoing including the introduction of any Bills that are required.

## FINANCIAL IMPACT

All costs associated with the stopping prohibitions on Bayview Ridge are included within the Transportation Services Division, North York District's 2007 Operating Budget.

#### **ISSUE BACKGROUND**

Transportation Services, North York District was requested by Councillor Cliff Jenkins on behalf of residents of Bayview Ridge to consider installing stopping prohibitions on both sides of Bayview Ridge just west of Bayview Avenue.

### COMMENTS

Currently, parking is permitted up to a maximum of three hours on both sides of Bayview Ridge from Bayview Avenue to Bayview Ridge Crescent.

Our investigation has verified that the continued parking of vehicles on both sides of Bayview Ridge, west of Bayview Avenue, is restricting the flow of traffic of vehicles exiting and entering Bayview Ridge.

In order to address residents' concerns regarding parking on Bayview Ridge, west of Bayview Avenue, it is recommended that stopping be prohibited between the hours of 8:00 a.m. and 6:00 p.m., Monday to Friday.

Councillor Cliff Jenkins has indicated his support for the recommended changes contained within this report.
