Removal of Parking Restriction: Forge Drive

SUMMARY

This staff report is about a matter that the Community Council has delegated authority to make a final decision (provided that it is not amended so that it varies with City policy or by-laws).

To obtain approval to remove the existing parking restrictions in front of No. 5 Forge Drive.

RECOMMENDATIONS

Transportation Services, North York District, recommends that:

1. Schedule VIII of By-Law No. 31001, of the former City of North York, be amended to delete the no parking at anytime prohibition on the east side of Forge Drive from the northerly limit of Potsdam Road to a point 55 metres north thereof;
2. Schedule VIII of By-Law No. 31001, of the former City of North York, be amended to prohibit parking at anytime on the east side of Forge Drive from the northerly limit of Potsdam Road to a point 45 metres north thereof; and
3. the appropriate City Officials be authorized and directed to take whatever action is deemed necessary to implement the foregoing including the introduction in Council on any bills that are required.

FINANCIAL IMPACT

All costs associated with the amendment of the parking regulations are included within the Transportation Services Division, North York District's 2007 Operation Budget.

ISSUE BACKGROUND

North York Community Council, at its meeting in March 2000 approved the installation of a “No parking at anytime” prohibition on the east side of Forge Drive from the north limit of Potsdam Road to the north limit of No. 7 Forge Drive, in order to facilitate Wheel Trans operations.

This division has recently been requested by the new owner of No.7 Forge Drive to remove the parking restrictions in front of his home.

COMMENTS

Currently, parking is prohibited at anytime on the east side of Forge Drive from the north limit of Potsdam Road to a point 55 metres north thereof (north limit of 7 Forge Drive). Parking is permitted on the east side of Forge, north of No. 7 Forge Drive and on the west side of the road for a maximum period of three hours.

This division has no objection with the removal of the parking restriction in front of No. 7 Forge Drive as per the resident’s request.

Councillor Anthony Perruzza has been advised of the recommendations contained within this report.
