Proposed Section 37 Implementation Guidelines: Status of Additional Requested Reports

(May 10, 2007) report from Chief Planner and Executive Director, City Planning

Summary

At the March 29, 2007 meeting of Planning and Growth Management Committee, Committee recommended adoption of the Proposed Section 37 Implementation Guidelines with a minor amendment. In addition, City Planning staff were requested to forward further reports, one with a specific timing of “in two months’ time”, meaning the May 31, 2007 Committee meeting. An Examination of Waterfront Free Fare Transit Options

(May 3, 2007) report from Chief Planner and Executive Director, City Planning

Summary

To respond to a request received from Planning and Growth Management Committee at its meeting of February 15, 2007 when considering Item 3a “Toronto Transit Commission’s Waterfront West Streetcars Environmental Assessment – Terms of Reference”, to report on a free originating zone fare system in the waterfront area as a marketing strategy.

Based on research and discussions with TTC staff, this report documents a range of operating proposals, and identifies a free fare system for all eastbound transit service operating on Queen’s Quay West between Bathurst Street and Union Station as an option that is likely to achieve the best “cost vs. new ridership” balance, and is the most practical from an operating perspective. Potential funding sources have also been reviewed, however, at this time no source has been identified to offset the expected fare revenue losses and operating costs associated with this proposal.

TTC staff have been consulted in the preparation of this report. Financial Impact There are no financial implications.

A New Class Environmental Assessment Process for Transit Projects

Making Building Plans Available To The Public Electronically

(Deferred from May 3, 2007 meeting in order that notice be given for Committee questions and debate - PG 4.5)

(April 19, 2007) report from Chief Building Official and Executive Director, Toronto Building

Summary

This report provides information on the steps that will be taken by Toronto Building to ensure that building plans, which are permitted to be disclosed in accordance with the Division's Routine Disclosure Policy and the Municipal Freedom of Information and Protection of Privacy Act (MFIPPA), are available to authorized requesters electronically and via the Internet.

Effective June 1, 2007, Toronto Building will inform individuals authorized to access building plans in accordance with MFIPPA and the Division's Routine Disclosure Policy that they may request copies of such plans in an electronic format.

Toronto Building will report in the fall of 2007 on necessary amendments to Chapter 363, Part II of the Toronto Municipal Code, to require the electronic submission of all required information, including building plans, in connection with applications to the Division, such as building and demolition permits. This change will enable Toronto Building to move forward with initiatives to make building plans more readily available electronically and via the Internet. Financial Impact There is no financial impact resulting from the receipt of this report.

Building Code Enforcement Issues

(May 16, 2007) report from Chief Building Official and Executive Director, Toronto Building

Summary

This report discusses the tools that are available to Toronto Building to stop the construction of buildings that do not conform to plans approved through the Building Permit process.

Section 8(13) of the Building Code Act prohibits the construction of buildings except in accordance with plans and specifications approved by the Chief Building Official. Despite this, sometimes the construction of buildings, for which a permit has been issued subject to a particular set of plans, is built with variations in the location and/or size of the building, or materials used in the construction of the building.

Improving the ability of Toronto Building Staff to stop work on construction projects that do not conform to approved plans will require a review of the existing inspections practices, manpower, fees for Building Permits, as well as a detailed review of the Building Code, and Building Code Act.

The recommendations contained in this report have no financial impact beyond what has already been approved in the current year's budget.

Adverse Effects Caused by the Issuance of Building Permits on Adjacent Buildings

(May 16, 2007) report from Chief Building Official and Executive Director, Toronto Building

Recommendations

The Chief Building Official and Executive Director, Toronto Building recommends:

1. Toronto Building, on behalf of the City of Toronto, propose an amendment to the Ontario Building Code regarding the issue of the separation of existing chimneys in relation to proposed adjacent residential buildings;
2. Council request the province to consider relevant technical requirements of other provincial and federal acts and regulations where building construction and/or

maintenance is governed by those acts or regulations, and construction may impact, or be impacted by adjacent buildings and properties; and

3. the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

Financial Impact

The recommendations will have no financial impact beyond what has already been approved in the current year's budget

Summary

This report outlines the legislative context and actions that Toronto Building proposes to take with respect to the impacts of infill housing construction on existing adjacent residential buildings.

New construction, particularly infill housing projects, can occasionally place adjacent buildings into non-compliance with a number of health and safety requirements of the Ontario Building Code, and other federal and provincial regulations.

It has been deemed that the Ontario Building Code cannot, except where specifically mentioned, govern proposed construction based on the impacts that it may cause to an adjacent property. It is recommended that Toronto Building recommend changes to be made to the Ontario Building Code, as well as explore other alternatives to limit the impact that new construction may have on existing buildings.

Committee Recommendations

On motion by Councillor Milczyn, the Planning and Growth Management Committee recommended that:

1. City Council authorize Toronto Building, on behalf of the City of Toronto, to propose an amendment to the Ontario Building Code regarding the issue of the separation of existing chimneys in relation to proposed adjacent residential buildings;

City Council request the Province to consider relevant technical requirements of other provincial and federal acts and regulations where building construction and/or maintenance is governed by those acts or regulations, and construction may impact, or be impacted by adjacent buildings and properties; and
3. the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

Vibrations Caused by Construction Activity

(May 16, 2007) report from Chief Building Official and Executive Director, Toronto Building

Recommendations

The Chief Building Official and Executive Director, Toronto Building recommends that:

1. The Chief Building Official and Executive Director, Toronto Building, report to Planning and Growth Management Committee with the necessary amendments to Chapter 363 of the City of Toronto Municipal Code to require details and particulars from building permit applicants relating to the potential for construction vibrations, and where there is the potential for construction borne vibrations to require conformance with a set of vibration control criteria. These criteria will include but are not limited to precondition surveys, vibration monitoring and conformance with peak particle velocity measurements appropriate to the site.
2. Toronto Building conduct a focused consultation with the building industry and resident's representatives to establish a communications protocol in order to appropriately document all public complaints.

Financial Impact

The recommendations will have no financial impact beyond what has already been approved in the current year's budget.

Summary

This report responds to Council direction for the Chief Building Official and Executive Director, Toronto Building to provide recommendations for regulating vibrations in the City of Toronto which are the result of construction activity. The recommendations are based on a technical research study recently completed for Toronto Building.

This report recommends that Toronto Building report back to the Planning and Growth Management Committee with amendments to the City of Toronto Municipal Code Chapter 363, Building Construction and Demolition following a focussed consultation. The amendments would require permit applicants to conform to a set of vibration control criteria where there is the potential for construction borne vibrations. This approach is proactive and provides measures and protections not likely available through a complaints driven approach. The report further recommends that Toronto Building develop a public communication policy in a focused consultation with the building industry and residents' representatives.
