SUMMARY

The purpose of this report is to advise on the results of the Request for Quotation (RFQ) 3920-06-0252, and to request the authority to award contracts in the amounts of \$7,339,633.10 net of GST to Lafarge Canada Inc., and \$1,312,600.18 net of GST to Moyer Aggregates Inc. for the supply and delivery of Quarried Crushed Stone Aggregates, Sand and Gravel to various locations within the City of Toronto, for Toronto Water and Parks, Forestry and Recreation for the period from the date of award to December 31, 2007.

A contract in the amount of \$11,687.88 net of GST has been awarded to Vicdom Sand & Gravel (Ont) Ltd. being the lowest bidder for Item 16A. In accordance with the Purchasing By-Law 195-9 (A), Toronto Municipal Code Chapter 195 – Section 9.

RECOMMENDATIONS

The General Manager of Toronto Water and the Director of Purchasing and Materials Management recommend that:

 Funds be reallocated within the approved 2007 Capital Budget of Toronto Water in the amount of \$2,200,000.00 net of GST from Account No. CPW028-03 – Clark Residue Mgmt Construction to Account No. CPW466-01 – 2006 Stream Restoration;

- 2. Subject to the approval of Recommendation (1), authority be granted to award the contract for the supply and delivery of Quarried Crushed Stone Aggregates, Sand and Gravel to Lafarge Canada Inc, being the lowest bidder for Items 1A, 2A, 4A, 5A, 6A, 8A, 9A, 10A, 12A, 13A, 14A, 17A, 19A, 20A, and 21A, for a total cost not to exceed \$7,339,633.10, net of GST for the period from contract award to December 31, 2007;
- 3. Subject to the approval of Recommendation (1), authority be granted to award the contract for the supply and delivery of Quarried Crushed Stone Aggregates, Sand and Gravel to Moyer Aggregates Inc., being the lowest bidder for Items 3A, 7A, 11A, 15A, 18A, 22A and 23A, for a total cost not to exceed \$1,312,600.18 net of GST for the period from contract award to December 31, 2007;

FINANCIAL IMPACT

The total contract award identified in this report is \$9,158,276.95 including all applicable taxes and charges. The cost to the City net of GST is \$8,663,921.16. Funding has been provided in the 2007 Operating and Capital Budgets in the respective Divisions. Since there are insufficient funds in the Toronto Water capital account CWW466 (2006 Stream Restoration), a budget adjustment is being recommended to transfer \$2,200,000.00 from CPW028 (Clark Residue Mgmt). This adjustment will have no net impact on the 2007 Toronto Water capital budget.

The Deputy City Manager and Financial Officer have reviewed this report and agree with the financial impact information.

BACKGROUND

Request for Quotation 3920-06-0252 was issued November 17, 2006 by Purchasing and Materials Management Division (PMMD) for the supply and delivery of Quarried Crushed Stone Aggregates, Sand and Gravel to various locations within the City of Toronto, for Toronto Water and Parks, Forestry and Recreation for the period from the date of award to December 31, 2007.

Eighteen (18) firms on the bidders' list were invited to submit bids and this requirement was advertised on the City of Toronto's Internet Website. The Request for Quotation closed and the prices from were read out at the public opening on December 1, 2006. Four (4) bids were received from Lafarge Canada Inc., Moyer Aggregates Inc., Vicdom Sand & Gravel (Ont) Ltd. and J. C. Rock Ltd. The bid submitted by J. C. Rock Ltd., was declared informal as they did not provide pricing by Triaxle Truck Loads as required in the RFQ.

A summary of the pricing received from Lafarge Canada Inc., Moyer Aggregates Inc., Vicdom Sand & Gravel (Ont) Ltd. is attached as appendix "B".

The contract value is based on usage estimates that were provided by participating Divisions, Toronto Water and Parks, Forestry and Recreation having regard for their 2007 Operating /Maintenance requirements.

COMMENTS

Toronto Water, Parks Forestry and Recreation reviewed the quotations received to ensure all criteria were met as required in the Request for Quotation 3920-06-0252.

Toronto Water, Parks Forestry and Recreation staff have compared the recommended bidder's prices to the estimated cost, and found the prices to be reasonable and within the adjusted budget. A comparison of the pricing received for 2007 against the contracted prices from June 18, 2005 to September 30, 2006 contract prices is attached as appendix "A".

The increase in price for this commodity can be attributed to the increased cost of producing aggregate products and manufacturing increases as identified in the Consumer Price Index, as well as the increased cost of Natural Gas and Fuel Oil used in the production and delivery of aggregates.

The Fair Wage Office has reported that the recommended firm has indicated that it has reviewed and understands the Fair Wage Policy and Labour Trades requirement and has agreed to comply fully.
