# Status Report Regarding the City of Toronto's Environmental Assessment of a Long-Term Post-Diversion Solid Waste Management System and the Community Environmental Assessment Team

#### SUMMARY

The purpose of this report is to provide Public Works and Infrastructure Committee with a status report on the City of Toronto's Environmental Assessment of a long-term post-diversion solid waste management system and high-light the work of the Community Environmental Assessment Team ("CEAT").

#### Financial Impact

There are no financial impacts arising from this report.

The 2007 recommended Capital Budget of Solid Waste Management Services has identified \$1.135 million cashflow in 2007 for the Environmental Assessment, which includes operating costs for the Community Environmental Assessment Team. The 2007 cashflow consists of a new request of \$0.870 million and \$0.265 million carry-forward from the under-spending in the 2006 approved Capital Budget of Solid Waste Management Services. The total budget in the recommended 5-year Capital Budget of Solid Waste Management Services for the EA project amounts to \$5.635 million.

The Deputy City Manager and the Chief Financial Officer has reviewed and concurs with the financial implications.

#### **DECISION HISTORY**

In 2001 City Council's Task Force 2010 identified in its report a significant role for new and emerging technologies to assist the City reach its objective of 100 percent diversion from landfill by 2010. Subsequent to the Task Force's report the New and Emerging Technologies, Policies and Practices Advisory Group ("NETPPAG") was formed comprised of citizens and experts in the solid waste management field. During the course of its work NETPPAG identified potential benefits from the engagement of new and emerging technologies, but recommended prior to their engagement that the City undertake an Environmental Assessment of a long-term solid waste management system in order to comprehensively assess the various classes of new and emerging technologies.

At its meeting of November 9, 2004, Works Committee had before it a communication from Deputy Mayor Joe Pantalone, Chair, Roundtable on the Environment, which contained advice, in response to a request from Works Committee, on the development of a Citizen Participation Model for Public Consultation Related to Solid Waste. The Committee approved in principle the Roundtable's Citizen Participation Model, requested a staff report regarding the administration, accountability and financial aspects of the model and authorized the Committee Chair and Vice-Chair to select the members of the Community Environmental Assessment Team ("CEAT"), the core component of the Roundtable's Citizen Participation Model.

City Council subsequently amended the Committee's recommendations to include consultation on the part of staff with the Chair and Vice-Chair of the Works Committee and Councillor Fletcher prior to the submission of a staff report.

On May 26, 2005, a staff report was submitted by the Deputy City Manager and Chief Financial Officer, City Solicitor and the General Manager of Solid Waste Management Services, which had been developed with the input of the aforementioned members of Works Committee. The staff report contained a draft mandate for CEAT, projected project budget, honoraria, a member selection process and a chronology of key decision points and steps. The report's associated recommendations were adopted by the Committee and Council.

A Community Environmental Assessment Team Nominating Panel comprised of former Councillor Pitfield, and Councillors Bussin, Carroll, and Giambrone was subsequently formed and, with the assistance of the Clerk's Office, sought applications for membership on CEAT and interviewed potential candidates.

At its meeting of January 21, February 1 and 2, 2006, City Council adopted the recommendations of the CEAT Nominating Panel (with one amendment due to an unsigned application) for the initial membership of CEAT. At that time twenty members were named, including Philip Knox as Chair and Lee Doran as Vice-Chair. Since that

time several members have resigned or taken sabbaticals, and three new members have joined.

#### **ISSUE BACKGROUND**

This report has been submitted to provide Committee members with a status report on a major initiative concerning the future of the City's solid waste management.

#### **COMMENTS**

Following the publication of its membership, CEAT held its first meeting in March of 2006.

The principle project consultant is MacViro Consultants, under the direction of David Merriman, Principal, who is assisted by consultants from the firm of Jacques Whitford. The external legal counsel is John Tidball of Miller Thomson LLP.

City staff from Solid Waste Management Services, City Legal and Policy, Planning, Finance & Administration (Communications and Public Consultation staff) are actively engaged in the EA.

Project staff have worked in a collaborative mode with CEAT since its initial meeting in March of 2006. Currently CEAT, project consultants and City staff are working to prepare a Terms of Reference ("ToR") for the EA. Under the Environmental Assessment Act proponents are required to prepare a ToR, with public consultation, and attain the approval of the Minister of the Environment before proceeding with the actual EA.

Since its inception, CEAT has developed and carried out a comprehensive work plan that has included administrative organization, guest speakers, research, input to the drafting of

the ToR and public consultation. A list of the major activities undertaken by CEAT in 2006 is presented in Appendix A of this report.

CEAT and project staff have also collaborated in the development of a project timeline. The current scheduled delivery of a draft ToR to Public Works and Infrastructure Committee is July 2007. A summary of the major project milestones is presented in Appendix B of this report.
