CEAT Update Report and Presentation – "Talking Trash: Options for Increasing Toronto's Waste Diversion Rate"

(January 31, 2007) letter from the Toronto Community Environmental Assessment Team.

Recommendations

That the Public Works and Infrastructure Committee allow time on their agenda of their February 14, 2007 meeting of 15-20 minutes to receive a summary Power Point slide presentation from representatives of the University of Toronto's Master Programme in Planning on the results of their report "Talking Trash: Options for Increasing Toronto's Waste Diversion Rate".

In July of 2006 the Community Environmental Assessment Team (CEAT) began canvassing some of the University of Toronto (U of T) Departments to determine their interest in getting involved with CEAT. It was felt by members of CEAT, based on their previous association with U of T, that there was significant resources and interest on the part of students and staff with becoming involved with the issues surrounding the City of Toronto's (City) waste challenges.

One of CEAT's members (Ian Caldwell) received a reply in August of 2006 from Philippa Campsie, co-ordinator of planning student workshop projects with the U of T Department of Geography and Programme in Planning interested in pursuing exploration of a potential project for a group of students.

Members from CEAT and Solid Waste Management Services (SWMS) met with Ms. Campsie in August to review ideas for the project and a CEAT co-ordinator (Karen Buck) volunteered to act as a liaison with the group.

The study period for the project spanned September through December of 2006 and the final report "Talking Trash: Options for Increasing Toronto's Waste Diversion Rate" was submitted and presented to CEAT on January 31, 2007.

(January 31, 2007) report from the General Manager, Solid Waste Management Services.

Recommendations

Solid Waste Management Services Division recommends that:

- 1. the General Manager, Solid Waste Management Services and the Chief Purchasing Officer be authorized to re-tender the former Etobicoke Residential Curbside Collection Contract No. 95-2001, with the exception of litter bin collection and commercial collection, which expires on June 30, 2008;
- 2. the General Manager, Solid Waste Management Services be authorized to out-source the front-end, multi-unit portion of recycling collection in the former North York and Scarborough areas that is currently provided by City forces when the existing equipment reaches the end of its asset life;
- 3. the General Manager, Solid Waste Management Services and the Chief Purchasing Officer be authorized to re-tender the following Multi-unit Residential Collection Contracts Contract No. 254-2002 (former North York and Scarborough expiring on January 31, 2008) and Contract No. 95-2000 (former East York, Etobicoke, Toronto and York expiring on June 30, 2008) into a single tender;
- 4. the former York Curbside Collection Contract No. 121-2000 not be re-tendered and that this operation be undertaken by City staff beginning August 7, 2007, subject to the approval of the confidential instruction to staff as noted in Attachment 1;
- 5. the former East York, Etobicoke, Scarborough and York White Goods Collection Contract No. 6033-03-3084 not be re-tendered and that these operations be undertaken by City staff beginning September 1, 2007;

- 6. the General Manager, Solid Waste Management Services be authorized to amend the operating hours at the City's transfer stations to allow for improved access to City and contractor collection vehicles; and
- 7. the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

Financial Impact

There are no immediate financial impacts as a result of the re-tendering of the collection contracts noted in Recommendation Nos. 1 and 3. The costs will become available upon tender closing by mid-2007 and will be reported separately for award of contract.

As a result of not re-tendering the former York Curbside Collection contract and adoption of the confidential instruction noted in Recommendation No. 4, the City would be saving the future contract cost which is estimated at approximately \$4 million annualized. The savings will be realized beginning in 2008.

The in-sourcing of work by City forces from the contract noted in Recommendation No. 5 would save the City the future re-tendered cost for these operations which is estimated at approximately \$400,000 annualized. The savings would be realized beginning in 2008.

The Deputy City Manager and Chief Financial Officer has reviewed this report and agrees with the financial impact information.

Summary

The purpose of this report is to seek authority to re-tender the contracted residential collection services in former Etobicoke and re-tender the contracted collections from multi-unit residential apartments City-wide.

This report is also seeking authority to in-source residential collection in former York and the collection of white goods in former East York, Etobicoke, Scarborough and York.

Supply and Delivery of Organic Collection Containers (Green Bin) and Latch Lock Kits

The intent of this report is to inform Committee of the amendment and extension to Contract No. 47011505 for the Supply and Delivery of Organics Collection Containers and Latch Lock Kits. For the purpose of this report Organics Collection Containers includes both the Residential Curbside Green Bin and the Kitchen Catcher.

Changes to the contract were needed to ensure that a supply of Green Bin Program products would be available to residents at a variety of venues throughout the City including Environment Day Events, Home Hardware locations, select Works yards and transfer stations.

The impact of not securing a 2007 supply of these products would have affected the residential Green Bin Program in the following ways:

- a. Additional Organics Collection Containers and Latch Lock Kits would no longer be able to be purchased;
- b. Broken Organics Collection Containers would no longer be able to be replaced;
- c. New residents would not have the opportunity to pick up a free Organics Collection Container set; and
- d. Diversion rate for the program would be negatively affected.

Street Name Signage Program

(January 10, 2007) report from the General Manager, Transportation Services.

Recommendations

Transportation Services recommends that:

1. the sign shown in Appendix No. 2 of this report and the design guidelines outlined in detail as Appendix No. 3 of this report, be adopted as the street name sign style for the City of Toronto;

- 2. street name signs be located on the right of way in accordance with the guidelines outlined in detail as Appendices No. 5A and No. 5B of this report;
- 3. decommissioned street name signs be made available for public purchase at a nominal cost of \$10.00 per sign, in accordance with the criteria outlined in detail as Appendix No. 6 of this report; and
- 4. the appropriate City officials be authorized to take whatever action is necessary to take effect thereto.

Financial Impact

There are no immediate financial impacts associated with the adoption of this report. The proposed continued replacement of street name signs but with the new design at a rate of 2,000 to 2,500 signs per year can be accommodated within the 2007 Recommended Operating Budget of Transportation Services. This current annual cost totals \$120,000 per year or between \$50.00 and \$60.00 per sign.

Two Options for Street Name Signage Program Enhancement are described in this report. These options would accelerate the replacement of signs, but as they would have significant impacts on the budget these options are not being recommended at this time. Option (A) would require an increase to the Operating Budget of approximately \$0.500 million. Option (B) would require the approval of a new capital project totalling \$3.000 million scheduled over three years.

The Deputy City Manager and Chief Financial Officer has reviewed this report and agrees with the financial impact information.

Summary

As one of its initiatives for the beautification and cleanliness of the road rights-of-way, City Council gave consideration to the consolidation and co-ordination of street name signage, to address the many issues of inconsistent colours, fonts, legibility, placement, size and shape that remain as legacies from the former municipalities.

This report proposes a program for the replacement of existing street name signage with signs that raise the current standard to a distinctive level, introduces commonality of colour and shape with the use of high quality of materials for the signs and their associated mounting hardware, including high level of reflectivity for improved legibility at all times of the day and, finally, proposes consistency and distinctiveness for those City neighbourhoods and BIAs that request specific identification and branding.

The proposed program also presents criteria for the standard location of street name signs within the right of way. It also suggests a process to make available to the public for purchase, those street name signs that have been decommissioned.

Research Project: Partnership with AUG Signals Inc. for Drinking Water Monitoring Pilot Project

The work to be undertaken is an incremental item, which will be absorbed by existing staff resources. There is an opportunity for Toronto Water to receive funding in the overall approximate amount of \$100,000 for a portion of staff time dedicated to undertake the three-year project.

The Deputy City Manager and Chief Financial Officer has reviewed this report and agree with the financial impact information.

This report seeks approval for Toronto Water to enter into a partnership agreement with AUG Signals Inc. for the purpose of undertaking a research project. The research project intends to develop an early warning monitoring system for the detection of threats or contaminants to water supply systems. Toronto Water has the opportunity to be involved in the development of an intelligent system not currently available to water service providers and, potentially, to be reimbursed for in-kind services. The project has the potential for future revenue if the new technology is commercialized.
