# Request for Quotation 3920-06-0252 - Supply and Delivery of Quarried Crushed Stone Aggregates, Sand and Gravel

(March 27, 2007) report from the General Manager, Toronto Water and the Director, Purchasing and Materials Management.

#### Recommendations

The General Manager, Toronto Water and the Director of Purchasing and Materials Management recommend that:

- 1. funds be reallocated within the approved 2007 Capital Budget of Toronto Water in the amount of \$2,200,000.00 net of GST from Account No. CPW028-03 Clark Residue Mgmt. Construction to Account No. CPW466-01 2006 Stream Restoration;
- 2. subject to the approval of Recommendation 1, authority be granted to award the contract for the supply and delivery of Quarried Crushed Stone Aggregates, Sand and Gravel to Lafarge Canada Inc, being the lowest bidder for Items 1A, 2A, 4A, 5A, 6A, 8A, 9A, 10A, 12A, 13A, 14A, 17A, 19A, 20A, and 21A, for a total cost not to exceed \$7,339,633.10, net of GST for the period from contract award to December 31, 2007; and

#### **Financial Impact**

The total contract award identified in this report is \$9,158,276.95 including all applicable taxes and charges. The cost to the City net of GST is \$8,663,921.16. Funding has been provided in the 2007 Operating and Capital Budgets in the respective Divisions. Since there are insufficient funds in the Toronto Water capital account CWW466 (2006 Stream Restoration), a budget adjustment is being recommended to transfer \$2,200,000.00 from CPW028 (Clark Residue Mgmt.). This adjustment will have no net impact on the 2007 Toronto Water capital budget.

# Basement Flooding Protection Subsidy Program

(April 16, 2007) report from the General Manager, Toronto Water.

#### Public Works and Infrastructure Committee - May 2, 2007 Minutes

#### Recommendations

The General Manager of Toronto Water recommends that:

- 1. the Basement Flooding Protection Subsidy Program be adopted as described in the attachment to this report; and
- 2. the General Manager of Toronto Water continue to monitor the implementation of the Basement Flooding Protection Subsidy Program and be authorized to revise or amend the type of basement flooding protection work ("Eligible Works") qualifying for a subsidy and the subsidy limits applicable to such work, subject to the total subsidy limit of \$3,200.00 per property, and to otherwise administer the Program, as the General Manager may deem necessary, to improve the effectiveness of the Program.

#### **Financial Impact**

The approved 2007 Capital Budget and Forecast for Toronto Water identifies multi-year funding in the amount of \$500,000 per year from 2007 to 2010, inclusive, for a total of \$2,000,000 in WBS Element CWW421-01 Basement Flooding Home Isolation Program.

#### Summary

The purpose of this report is to seek Council approval for the terms and conditions of a new City-wide Basement Flooding Protection Subsidy Program ("BFPSP"). In the past, this Program was made available only to those property owners, as specifically approved by Council, who had filed a basement flooding complaint during a particular storm event. Implementation of all the works identified in the Program provides an individual property owner the maximum basement flooding protection from sewer back-up situations.

In July 2006, Council authorized staff to develop a new City-wide Basement Flooding Protection Subsidy Program as part of the 2007 Toronto Water Budget process. This report outlines the details of the program and clarifies that subsidies are available to owners of existing single, duplex or tri-plex residential buildings, regardless of their flooding history and describes the communication and education activities proposed to be undertaken in support of this program.

#### **Committee Recommendations**

On motion by Councillor Carroll, the Public Works and Infrastructure Committee recommends that:

- 1. the Basement Flooding Protection Subsidy Program be adopted as described in the attachment to this report;
- 2. the General Manager of Toronto Water continue to monitor the implementation of the Basement Flooding Protection Subsidy Program and be authorized to revise or amend the type of basement flooding protection work ("Eligible Works") qualifying for a subsidy and the subsidy limits applicable to such work, subject to the total subsidy limit of \$3,200.00 per property, and to otherwise administer the Program, as the General Manager may deem necessary, to improve the effectiveness of the Program; and

# Mitigation of Stormwater Overflow from Kew Gardens

(April 17, 2007) report from the General Manager, Toronto Water.

#### Recommendations

The General Manager, Toronto Water recommends that:

1. pending the results of consultation with the affected community regarding the proposed flood protection works, the Parks, Forestry and Recreation Division be authorized to undertake site regrading, including the planting of additional trees, at the southwest corner of Kew Gardens Park to provide flood protection to the homeowners along Waverley Road and that the cost of such work be paid for by Toronto Water as part of the 2007 capital works program.

#### **Financial Impact**

Funding in the amount of \$30,000.00 for this initiative is available in the approved 2007 Toronto Water Capital Budget, WBS Element CWW421-05 – Basement Flooding.

#### Summary

The purpose of this report is to present the findings of investigations into measures on mitigating stormwater overflow onto private property from Kew Gardens Park. It is being recommended that minor adjustments to site grading be undertaken, including the planting of additional trees, at the southwest corner of Kew Gardens Park to provide flood protection to abutting Waverley Road properties. The proposed work will not impact recreational activities in the park and could be completed this year.

#### **Committee Recommendations**

On motion by Councillor Giambrone, the Public Works and Infrastructure Committee recommended that:

# **Research Contributions - Toronto Water**

(April 17, 2007) report from the General Manager, Toronto Water.

#### Recommendations

The General Manager, Toronto Water recommends that:

- 2. authority be granted to provide our annual subscription to the Water Environment Research Foundation in the amount of \$108,600 for 2006, up to \$111,800 for 2007, up to \$115,200 for 2008, up to \$118,600 for 2009, and up to \$122,200 for 2010;
- 3. authority be granted to continue our partnership with and contribute up to \$25,000 per year to the Ontario Water Works Research Consortium for 2007, 2008, 2009 and 2010;
- 4. authority be granted to contribute \$50,000 per year to the Research Chair in Water Treatment at the University of Waterloo for 2007, 2008, 2009, 2010, 2011 and 2012;
- 5. authority be granted to contribute up to \$50,000 per year to an appropriate contract research firm subject to approval by the General Manager of Toronto Water; and
- 6. City Council authorize and direct the appropriate staff to take the necessary action to give effect thereto.

#### **Financial Impact**

The total estimated impact identified in this report is \$2,071,400 including all applicable taxes and charges over a six-year time period. For 2006, contribution to the Water Environment Research Foundation (WERF) has been set up as a liability in the amount of \$108,600 within the 2006 Operating Budget cost centre WW4030. For all other requests, funding has been consolidated into one cost centre PW1056-5200 – Operations Efficiency. Funding for all 2007 research requests has been budgeted for in the Toronto Water Operating Account. Funds for future years will be provided in the appropriate future Annual Operating Budgets. ### Ashbridges Bay Treatment Plant Mediation Agreement Compliance Report

The Sixth Interim Compliance Report from the ICMC summarizes the ICMC's concerns with respect to the implementation of the Ashbridges Bay Treatment Plant EA Mediation Agreement and provides a set of recommendations for each concern raised which staff have responded to on a recommendation-by-recommendation basis in the attachment to this report.

The concerns raised by the ICMC are largely related to differences in the interpretation of the Mediation Agreement and dissatisfaction with the outcome of various master planning processes undertaken by Toronto Water. These concerns have been raised in previous reports and in submissions made by the ICMC throughout the comment period allotted during the public review and commenting period associated with each of the planning processes. Toronto Water has considered the issues raised in the decision making process associated with these plans and responded to the concerns raised in the past. Toronto Water is committed to the implementation of these plans and complete the few remaining tasks in order to fulfil the commitments contained within the Mediation Agreement.

# Use of Public Sidewalks by Licensed Entertainment Facilities

(April 18, 2007) letter from Councillor Adam Vaughan, Ward 20, Trinity-Spadina.

#### Summary

# Ingram Reuse Centre and Other Potential Reuse Properties

(April 18, 2007) report from the Acting General Manager, Solid Waste Management Services.

#### **Recommendations**

The Acting General Manager, Solid Waste Management Services recommended that:

- (1)the vacant lands abutting the Ingram Transfer Station be used by Solid Waste Management Services for site modifications to improve operational efficiencies and customer services at the Ingram Transfer Station and as a potential location for one of eight City-owned reuse facilities;
- (2)community improvements that would enhance green space in the area near the Ingram Transfer Station be explored and implemented where feasible, should the lands abutting the Ingram Transfer Station be selected as a site for a reuse centre; and
- (3) staff work with Facilities and Real Estate and other divisions to develop a list of other City-owned properties as potential locations for reuse centres, and that, if a sufficient number of City-owned sites are not available, SWMS be authorized to seek the services of a real estate broker to find suitable private properties available within the City to purchase or lease.

#### **Financial Impact**

There are no financial implications arising from this report at this time. However, if Solid Waste Management Services were denied the right to use the vacant lands at Ingram Transfer Station, significant costs could be incurred to purchase industrial land with comparable features. The estimated cost for acquiring a similar parcel of land, according to figures provided by Facilities and Real Estate, is \$2.44 million.

Should the vacant lands not continue to be considered as a feasible location for a City-owned reuse facility, the operational costs in the form of staffing and equipment allocation would increase as the current plans rely upon the operation of these facilities in tandem. Additionally, customer service may suffer as the proximity of these facilities at the Ingram property is ideal in providing seamless waste reuse, recycling and removal opportunities for residents.

Capital and operational financial implications arising from the reuse centres will be provided as each individual facility is recommended.

#### Summary

The western portion of the Ingram Transfer Station property, which is not currently used for waste management activities, but falls under the jurisdiction of Solid Waste Management Services, is an ideal site to improve the operation of the Ingram Transfer Station, including improved traffic flow and better access to the bi-level recycling depot and household hazardous waste (HHW) depot for residents and improved storage and transfer of yard waste and white goods. The site also holds promise as a potential reuse facility. Community improvements that

would enhance green space in the area will be explored and implemented where feasible.
