## Request to designate 23 Doerr Road as a Natural Garden

### SUMMARY

The purpose of this report is to consider a request by the owner(s) of 23 Doerr Road to be exempted from Chapter 489 - Grass and Weeds, section 489-2. This section states that the maximum height of grass and weeds cannot exceed 20 centimetres. This report is to consider this exemption request in accordance with Chapter 489, Grass and Weeds, section 489-3(E)(6) and have their yards(s) designated a Natural Garden, as follows:

- (6) An owner or occupant requesting a review of a notice, and any other interested person, shall be heard by the community council which may recommend that Council:
  - (a) Grant the exemption, with or without conditions, and cancel the notice; or
  - (b) Confirm the notice and direct that a second notice be given under this section.

#### RECOMMENDATIONS

- 1. Parks, Forestry and Recreation-Natural Environments, states that this is a natural garden. Therefore Municipal Licensing and Standards recommends that the exemption be granted, subject to the following conditions:
  - a. The natural garden being limited to private property only; and
  - b. The natural garden be kept to a maximum of one meter in height within 2.4 metres of the front property line.

### **Financial Impact**

There is no financial impact anticipated in this report.

#### **DECISION HISTORY**

A Notice of Violation was issued to the owner(s) of 23 Doerr Road. The owner(s) requested by letter to Municipal Licensing and Standards for a natural garden exemption.

#### **ISSUE BACKGROUND**

A public complaint reported grass in excess of 20 centimetres. A Notice of Violation was issued. Public Heath Department was advised concerning rats in the area but do not inspect on private residential land. Under the Toronto Municipal Code Property Standards Chapter 629-9 Municipal Licensing and Standards investigated the following addresses for rodents;

- 25 Doerr Road- owner contacted, 3 inspections no rodents,
- 21 Doerr Road- no contact with owner, 3 inspections no rodents
- 22 Hathway Drive-owner has seen rodents
- 26 Hathway Drive- owner has seen rodents and indicated they may come from a sewer at 28 Hathway Drive.(see photo)
- 28 Hathway Drive- private sewer grate in rear yard property line

Municipal Licensing and Standard during its inspections found no evidence of rodents.
