Transportation Services has evaluated a request to designate exclusive northbound left-turn and right-turn lanes at the intersection of St. Clair Avenue West and Christie Street. Safety concerns have been raised due to a recent collision in which a northbound vehicle lost control and mounted the north side sidewalk. Designating exclusive northbound turn lanes on Christie Street at St. Clair Avenue West, in conjunction with other measures, will provide better guidance to motorists and reinforce that Christie Street ends at St. Clair Avenue West.
