SUMMARY

Transportation Services has been requested by Councillor Michael Walker to obtain authority to reduce the existing hours of Permit Parking from (12:01 a.m. to 10:00 a.m.), to operate from 12:01 a.m. to 8:00 a.m., to accommodate a 10-minute maximum "Student Pick-up/Drop-off Area", to operate from 8:00 a.m. to 10:00 a.m., Monday to Friday, on the south side of Manor Road East, from Redpath Avenue to the west leg of Servington Crescent.

This proposal will provide a sufficient area for parents/guardians to park while escorting their children to the e.p.i.c. School, located at 111 Manor Road East, without adversely affecting parking for those persons with parking permits.

RECOMMENDATIONS

Transportation Services recommends that:

1. the existing permit parking regulation in operation on Manor Road East from 12:01 a.m. to 10:00 a.m., be adjusted to operate from 12:01 a.m. to 8:00 a.m., from Redpath Avenue to the west branch of Servington Crescent; and
2. parking be permitted for a maximum period of ten-minutes from 8:00 a.m. to 10:00 a.m., Monday to Friday on the south side of Manor Road East, from Redpath Avenue to the west branch of Servington Crescent.

ISSUE BACKGROUND

At the request of Councillor Michael Walker, on behalf of representatives of the e.p.i.c. School, we reviewed the feasibility of reducing the operating hours of permit parking on the south side Manor Road East, in order to provide short-term parking opportunities for the parents/guardians of children dropping-off children at the e.p.i.c. School, located within the Church of Transfiguration, 111 Manor Road East.

COMMENTS

Permit Parking is in effect on the south side of Manor Road East, from 12:01 a.m. to 10:00 a.m., daily, from Redpath Avenue to the west leg of Servington Crescent. Parking is allowed on the south side of Manor Road East, from Redpath Avenue to the west leg of Servington Crescent, for a maximum period of one hour from 10:00 a.m. to 6:00 p.m., daily and is permitted for a maximum period of three hours at other times.

Results of Transportation Services Investigation

Transportation Services has no objections to the implementation of the requested student Pick-up/Drop-off area, which would operate for a maximum period of ten minutes from 8:00 a.m. to 10:00 a.m., Monday to Friday. Based on our assessment, a 10-minute maximum parking "Student Pick-up/Drop-off Area" could be introduced on the south side of Manor Road East, from Redpath Avenue to the west branch of Servington Crescent. However, as permit parking currently operates from 12:01 a.m. to 10:00 a.m., daily, it will be necessary to adjust the existing hours of operation of permit parking so that it does not conflict with the proposed implementation of the ten minute parking regulation.

The reduction in the hours of operation of permit parking to end at 8:00 a.m., daily within the subject area, will not negatively impact the holders of parking permits since permit parking is not a high priority in the area. Additionally, since parking would only be allowed for a maximum period of ten minutes between 8:00 a.m. and 10:00 a.m., Monday to Friday, it is unlikely that the adjustment of the permit parking hours would encourage any incidences of long-term non-resident/commuter parking.
